#### **7.3 Curriculum Committee**

##### **7.3.1 Resolution Memorandum**

The resolutions brought forward from the February 15<sup>th</sup>, 2019 Senate Curriculum Committee meeting were presented to Senate for approval.

On review of the Resolution Memorandum, the following two issues were raised with regard to Resolution #19/06:

- The prerequisite sequencing of ENGL 112. ENGL 112 will be added to the list of prerequisites for ENGL 100. However, one other prerequisite non-native speaker students can meet to gain entry to ENGL 100 is an IELTS score of 6.5 with no band score lower than 6.0. This IELTS level is the same as the English Language Requirement for Capilano University. Therefore, students could enter Capilano meeting the 6.5 IELTS requirement for ENGL 100 and take ENGL 100 without taking ENGL 112. Likewise, students could take ENGL 100 before ENGL 112 or take both concurrently. The lack of control over the sequencing seems to go against the seeming purpose of ENGL 112—that it precede ENGL 100 to prepare students for ENGL 100.
- EAP believes that it would better serve the needs of non-native speakers who are beyond the EAP levels to bridge the new ENGL 112 course with a newly-

created EAP course so that the specific linguistic needs of non-native speakers are better met. It is the hope of the EAP Department to work with the English Department in the coming year to investigate such a bridging model.

On discussion, it was noted that in the coming year, there would be an opportunity for reassessment and to revisit and address issues that may arise.

- A list of principles used to make resource allocations. The principles include, transparency, conservatism in revenue, resourcing according to priorities, additional resourcing principles and beyond budgeting.
- A process ranking initiatives (categorization, prioritization, evaluation, prioritization within the themes and approval based on funding available).
- The Committee was informed that work is underway on identifying a series of finance policies that require revision and a communication piece for the University community to highlight initiatives and to plan future enrolment strategies.
- The key assumptions used to develop the 2019/20 budget include:
  - Operating grant and enrolment target from the provincial government will remain consistent with 2018/19;
  - Estimated increases from the provincial government have been included for the collective bargaining increases and the employer health tax;
  - Tuition and mandatory fees include a 2% increase, consistent with past years, and consistent with direction from the provincial government;
  - Considerable work has been done to understand other revenues such as project and other revenue, sales of goods (bookstore revenues) parking, childcare and theatre, investment and donations.

The Committee was also informed that the date for Board approval of the budget was moved to April and, as such, the next Committee meeting was scheduled for March 12<sup>th</sup>.

- The University has been involved in conversations on how it can continue to work in partnership with other post-secondary institutions and organizations where there are shared interest and activities. These activities and partnerships usually take the form of education pathways, academic scholarly activity, research, etc., and an update of activity will be forthcoming.
- The Universities Canada submission work continues with the Universities Canada submission and everyone involved in the process was acknowledged

for their work. It is anticipated that the application may go to the April Board meeting.

- Programs, faculty and staff involved in the recent completion of program review and program development were acknowledged for their work and expertise.
- The Student Appeals Committee is in place and as part of the policy and expectation of supporting training for Committee members, a first training session was held in February and a second session will be scheduled in later March.
- The University has partnered with the Capilano Student Union on a gender diversity audit and results were presented at an open meeting. There were 36 recommendations and work has already begun to identifying priorities and moving into action activities over the foreseeable future, including consideration of inclusive language across the University.

#### 8.4 Board Report

Duncan Brown, Board representative reported that the Board met on February 26, 2019. This meeting was the first of several Board meetings dedicated to Envisioning 2030 – the university's strategic planning initiative. A brief summary was also provided of Board work currently underway.

The next Board meeting is on March 19, 2019 and at Kálah-ay Sunshine Coast Campus. The Board will also be meeting with the Sunshine Coast Mayors.

### BACKGROUND

On June 6, 2018, Senate approved policy S2018-02 Student Awards. This policy establishes criteria for awards recognizing academic excellence as well as all other awards given to students for transparency and consistency at the University.

Prior to the approval of S2018-02, the funding approach did not provide the Registrar's Office with the ability to forecast funding requirements. The current policy brought together details related to all funds and allocates current funding levels through the models of scholarships, awards, bursaries and prizes while ensuring an equitable model that provides access to students across all Faculties.

Appendix A to the policy lists all awards distributed by the Registrar's Office. This Appendix is available to students on the CapU website.

The University Act states that Senate is responsible for setting the "criteria for awards recognizing academic excellence" (section 35.2(5)(i)). S2018-02 sets the criteria for these awards. Section 27 of the University Act sets out the powers of the Board, including "to provide for chairs, institutes, fellowships, scholarships, exhibitions, bursaries and prizes the board and the senate consider advisable".

With Senate's approved the policy, it was intended that any changes or amendments to Appendix A would be presented to the Senior Leadership Council (SLC) for approval, and then shared with Senate as information. SLC is responsible for the day to day management of the University's operations (B.308 Board of Governors Charter), including the President's responsibility for the allocation and supervision of all appropriated and other funds that finance any activities under the jurisdiction of the University (B.502 President - Responsibilities).

### DETAILS OF REVIEW AND CHANGES

A substantial review of Appendix A University-Funded Student Awards was conducted in the Fall 2018 term, and the recommended amendments below are based on the desire to:

- add clarity related to student award disbursements
- efficiently disburse available funds
- fully disburse available funds

These amendments were recommended for immediate implementation for both 2019/2020 Student Entrance Awards and 2019/2020 Continuing Student Awards:

- 1) Change in criteria for Capilano Community Leadership Award (CCLA) for the new program category

*Rationale*

- To provide additional opportunities for alignment with instructional priorities and to support full disbursement of these awards, given that in any year there may not be sufficient new programming to meet the terms of the current criteria
- 2) Clarity on how funds will be used for the Capilano Community Leadership Award (CCLA) if there are insufficient applicants to any one category

*Standard statement added to each CCLA category: If there are insufficient applications in this CCLA category, any unutilized funds will first be considered for applications in the other two CCLA categories*

*Rationale*

- To ensure effective use and support full disbursement of available funds
- 3) Information added to each University-Funded Student Award to indicate if it is open to domestic students only, international students only, or both domestic and international students

*Rationale*

- To be clear on the current practice for each University-Funded Student Award; no changes in practice have been made
- 4) Created and Revised Dates added to the footer of the document

*Rationale*

- To be clear when the University-Funded Student Awards document was established and when the last revision to the document was made

At the March 6, 2019 meeting, the Senior Leadership Council to approves the amendments to Appendix A University-Funded Student Awards as presented.

*Proposed Motion: That Senate receive as information the revised Appendix A associated with policy S2018-02 Student Awards as approved by Senior Leadership Council.*

# University-Funded Student Awards

## Appendix A

### University-Funded Student Entrance Awards

Student Entrance Awards are made available annually and are in the form of a standard tuition fee waiver plus tuition surcharges for domestic students, and in some cases international students, who are enrolled in an undergraduate program that is a minimum duration of sixteen (16) months.

#### *Capilano Excellence Scholarship (#0663)*

The Capilano Excellence Scholarship is the premier entrance scholarship awarded by the university to recognize high school applicants with documented exemplary leadership in their school and community and demonstrated academic excellence, based on secondary school averages in core subjects.

*Note: Applicants must have graduated from high school a maximum of eighteen (18) months prior to the start of their program.*

#### *Capilano Community Leadership Award (replacing CAPA #0670 and CAPP #0671)*

The Capilano Community Leadership Award is awarded by the university to recognize applicants with documented leadership and volunteerism in the community and demonstrated strong academic standing.

- If there are insufficient applications in this CCLA category, any unutilized funds will first be considered for applications in the other two CCLA categories.

- Five (5) awards for applicants to new programs or programs prioritized for recruitment, with at least one award per identified program per year. The Vice-President Academic and Provost will determine the qualifying programs annually using the following established criteria:
  - Programs, with a credential at the undergraduate level or higher, whose first intake falls within the academic year that the entrance award will be offered or the prior two academic years.
  - Programs, with a credential at the undergraduate level or higher, that are prioritized for recruitment for the academic year that the entrance award will be offered

If more than 5 programs meet either of the definitions above in a given academic year, programs will be selected based on the following criteria:

- programs for which the CCLA has not been previously awarded
- programs whose first intake is within the academic year that the entrance award will be offered, and then, if needed, within the prior academic year
- programs that align with Ministry of Advanced Education, Skills & Training mandates

If less than 5 programs meet the established criteria above, or there are insufficient applications in this CCLA category, any unutilized funds will first be considered for applications in the other two CCLA categories.

*International Student Entrance Award (#0896)*

The International Student Entrance Award is awarded by the university to recognize international applicants to a Capilano University undergraduate program, English for Academic Purposes (EAP) program, or EAP pathway program with documented engagement and involvement in school initiatives and activities and demonstrated strong academic standing.

Award Value: Up to \$1,500 towards tuition and tuition surcharges

*Capilano University Athletic Award (#0683)*

**PURPOSE**

To fine tune an existing policy.

**BACKGROUND**

Senators are being asked to consider the revisions for 2.6 of this policy only. These changes serve program development and approval processes, so that this portion of the policy is updated. If we had more time, this policy would likely be revised into two or three separate policies, but we do not have time to meet the program approval timelines.

**DISCUSSION**

Senators are reminded to focus solely on the changes to 2.6 of this policy.

## Background

**S2015-05** does not include minimum requirements for Honours programs, Joint Majors, and Double Majors. In addition, the current policy sets higher minimum upper-level requirements for Concentrations and Minors than is typically found at comparator institutions.

In order to support the objective of expanding the range of credential options available to Capilano University students and in support of the credential development activities currently underway throughout the university, the Office of the VP Academic & Provost proposes the following additions and revisions to **Section 2.6 of S2015-05 Credential and Course Criteria**:

1. Honours (new)
2. Minors (revision)
3. Concentrations (revision)
4. Joint Major (new)
5. Double Major (new)
6. Major-Minor (new)
7. Double Minor (new)

With the exception of the proposed Honours requirements, the additions and revisions are in line with sector norms with a particular emphasis on the standards adopted at comparator institutions such as Kwantlen Polytechnic University, Thompson Rivers University, and the University of the Fraser Valley.<sup>i</sup>

The proposed changes will ensure that the four credentials currently in Stage 2 of the degree development process can be developed in accordance with sector norms for Minors and Concentrations as well as providing the option for students to complete Double Majors, Major-Minors and Double Minors. The additions and revisions to S2015-05 will permit current and future credential developers to design a wide range of flexible credential options in a timely fashion, including the option, for Honours degrees.

In addition to the above revisions and additions, minor housekeeping changes are also proposed:

1. Removal of specific Cap Core requirements from sections 2.3 and 2.4.
2. The references to "em" dashes have been replaced with dashes in sections 6.2.5 and 6.4.3 to accommodate operations currently allowed in Banner.
3. Section 6.7 now refers to Graduate Certificates (2.9) and Diplomas (2.10); Certificates are missing in the current version of the policy.

## Consultation

The proposed changes have been reviewed by the following communities:

1. Registrar's Office
2. Academic Initiatives & Planning Office (AIPO)
3. Policy Office
4. Academic Leadership
5. Program areas interested in the delivery of an Honours program – e.g. Communications, Early Childhood Care & Education, Liberal Studies, and Motion Picture Arts.
6. Degree development working groups as per list provided by AIPO.

During the consultation process, English, Early Childhood Care and Education, and Human Kinetics all spoke in favour of the reducing the minimum requirements for Minors and Concentrations to mirror sectors norms. The School of Communications expressed concerns regarding their ability to accommodate the minimum requirements for an Honours programs based on their current degree structure. The Early Childhood Care and Education School observed that there are currently no university limits on the assignment of upper level transfer credits.

In turn, the Sector Review completed to guide the proposed changes to Section 2.6 suggests that it is more conventional to have separate Credential and Course Policies. As such, the Office of the VP Academic & Provost and the Bylaw, Policy, and Procedures committee recommends that these policies be reviewed immediately with a careful consideration of sector norms alongside a second review of S2015-05 with the proposed objective separating the Credential and Course Criteria into at least two or more policies.

In the interim, however, to assist the University's commitment to the immediate expansion of credential opportunities at the university, the Bylaw, Policy, and Procedures committee recommends proceeding with the proposed revisions, additions, and housekeeping changes.

<sup>i</sup> With the objective of supporting a flourishing culture of undergraduate research, scholarly, and creative activity, the proposed minimum requirement for Honours programs sets a higher exiting CGPA than is typically seen in the system while requiring at least 6.00 credits of project-based research or an honours thesis in addition to the standard degree or Major program requirements as opposed to the additional 12.00 or more credits often required elsewhere with a minimum CGPA of 3.33.

## 1 PURPOSE

This policy outlines the requirements for credentials including definitions of the various credentials, definition of a credit hour, and definitions of course level and numbering.

## 2 REQUIREMENTS FOR CREDENTIALS

2.1 Below are outlined the minimum requirements for credentials offered at Capilano University.

### 2.2 Citation

2.2.1 Six (6) credits

2.2.2 Approved only with special authorization of the Vice-President Academic and Provost

### 2.3 Certificate

2.3.1 Fifteen (15) credits, including Cap Core curriculum requirements

2.3.2 Three (3) credits of English (ENGL) or Communications (CMNS) courses

~~2.3.3 Six (6) credits of Cap Core curriculum (three (3) credits foundation; three (3) credits professional practice)~~

### 2.4 Diploma

2.4.1 Sixty (60) credits, including Cap Core curriculum requirements

2.4.2 Six credits (6) of English (ENGL) and/or Communications (CMNS) courses

~~2.4.3 Twelve (12) credits of Cap Core curriculum (six (6) credits foundation; six (6) credits professional practice)~~

### 2.5 Associate Degree

2.5.1 As defined by the Ministry of Advanced Education, Skills & Training

## 2.6 Baccalaureate Degree

- 2.6.1 A minimum of one hundred twenty (120) credits, including Cap Core curriculum requirements
- 2.6.2 ENGL 100 within the first thirty (30) credits
- 2.6.3 A minimum of three (3) additional credits in English (ENGL) or Communications (CMNS) courses other than ENGL 100
- 2.6.4 Three (3) credits in a Quantitative/Analytical course approved by Senate Curriculum Committee

~~2.6.5 Twenty four (24) non baccalaureate discipline credits, which may include courses used to satisfy the Quantitative/Analytical, English language, and Cap Core requirements~~

A minimum of twenty-four (24) credits outside of degree program or Major requirements, which may include courses used to satisfy the Quantitative/Analytical, English language, and Cap Core requirements

2.6.6 Honours requires the completion of the degree program or Major requirements as well as, at a minimum, an additional six (6) credits of project-based research or an honours thesis and an upper-level CGPA of 3.50.

2.6.7 Majors require the completion of a minimum of thirty (30) upper-level credits in the major subject or field of study.

2.6.8 Minors require the completion of a minimum of fifteen (15) upper-level credits in the



minor subject or field outside of a student's Honours, Major, or degree program areas. Minors can be attached to any Bachelor's degree.

2.6.9 Concentrations require the completion of a minimum of twelve (12) upper-level credits within the Major or degree program and represent an increased focus on a particular area of study.

2.6.10 Joint Major programs require the completion of a minimum of thirty (30) upper-level credits in the joint major subjects. Programs may be combined within a Faculty or across Faculties; however, the overall degree requirements of at least one Faculty must be met.

2.6.11 Major/minor programs require the completion of the major requirements of one subject or field of study and the minor requirements of another subject or field of study within a single degree. Programs may be combined within a Faculty or across Faculties; however, the overall degree requirements of at least one Faculty must be met. This may require the completion of more than 120 credits.

2.6.12 Double major programs require the completion of the major requirements of each of the two subjects or fields within a single degree. Programs may be combined within a Faculty or across Faculties; however, the overall degree requirements of at least one Faculty must be met. This may require the completion of more than 120 credits.

2.6.13 Double minor programs require the completion of the minor requirements of each of the two subjects or fields within a single degree. Programs may be combined within a Faculty or across Faculties; however, the overall degree requirements of at least one Faculty must be met. This may require the completion of more than 120 credits.

## 2.7 Post-baccalaureate Certificate

2.7.1 Fifteen (15) upper-level credits.

2.7.2 Completion of a baccalaureate degree that is normally in a different discipline.

2.7.3 Must not include a concentration or a minor.

## 2.8 Post-baccalaureate Diploma

2.8.1 Thirty (30) upper-level credits.

2.8.2 Completion of a baccalaureate degree that is normally in a different discipline.

2.8.3 May include a concentration or a minor.

## 2.9 Graduate Certificate

2.9.1 Fifteen (15) graduate-level credits.

2.9.2 Completion of a baccalaureate degree that is normally in the same or a similar discipline.

## 2.10 Graduate Diploma

2.10.1 Thirty (30) graduate-level credits.

2.10.2 Completion of a baccalaureate degree that is normally in the same or a similar

discipline.

### **3 CREDIT HOUR**

- 3.1 Normally, a credit hour is defined as one (1) hour of instruction per week over a 15-week period.

### **4 TIMELINES**

#### **4.1 Credential Requirements**

- 4.1.1 Programs have until their next program review or three (3) years from October 2015 (the original policy approval date), whichever comes first, to align with this policy.

#### **4.2 Cap Core Requirements**

- 4.2.1 The timeline for implementation of Cap Core requirements for certificates and diplomas is approved by Senate.

### **5 COURSE LEVEL AND NUMBERING**

- 5.1 It is expected that individual courses include student learning outcomes reflective of the appropriate level of attainment as set out in Bloom's Taxonomy or similar framework. The first digit of the course number (e.g. 1xx) indicates the defined course level.

#### **5.2 Preparatory courses (0xx)**

- 5.2.1 These courses assist students to develop the necessary knowledge and skills to meet the requirements for university-level work. Credits for pre-university courses do not count toward diploma and degree programs.

#### **5.3 Lower-level courses (1xx or 2xx)**

- 5.3.1 5.3.1 These courses develop the knowledge, skill base, and educational maturity necessary for increasingly independent and advanced work at the upper level.
- 5.3.2 Prerequisites may include completion of specific courses and/or a specific number of accumulated university-level credits.

#### **5.4 Upper-level / post-baccalaureate courses (3xx or 4xx)**

- 5.4.1 These courses require a level of educational maturity that allows for more independent, advanced, and/or in-depth work than at the lower level. These courses are characterized by a structure that allows for a variety of approaches to the subject matter, a wide range of course material, and an emphasis on independent work in the laboratory, library, studio, field, community, or workplace.
- 5.4.2 Upper-level courses strongly emphasize comprehension, analysis, synthesis, evaluation, and application of knowledge and skills. Students are expected to accept

increasing responsibility for their own learning both inside and outside the classroom.

5.4.3 Prerequisites may include completion of specific courses and/or a specific number of accumulated university-level credits.

5.5 Graduate-level courses (5xx or 6xx)

5.5.1 These courses are intended for students in programs that require completion of a baccalaureate degree for admission. These courses build on knowledge and skills developed in the undergraduate program.

5.6 Numbering

5.6.1 Course numbers are assigned at the discretion of the Registrar's Office in consultation with the department.

## 6 CREDENTIAL NOMENCLATURE

6.1 Credentials will be identified before any areas of specialization.

6.2 Citations, Certificates and Diplomas

6.2.1 Credentials of this type will be named as follows:

6.2.2 Citation in [PROGRAM NAME]

6.2.3 Certificate in [PROGRAM NAME]

6.2.4 Diploma in [PROGRAM NAME]

6.2.5 When appropriate, the program name will be followed by an ~~em~~ dash and the field of study.

E.g. Certificate in Early Childhood Care and Education – Infant and Toddler, Diploma in Human Kinetics – Exercise Science.

6.3 Associate Degrees

6.3.1 Credentials of this type will be named as follows:

6.3.2 Associate of [PROGRAM NAME] – [Field of Study]

E.g. Associate of Science – Biology.

6.4 Baccalaureate Degrees

6.4.1 Credentials of this type will be named as follows:

6.4.2 Bachelor of [PROGRAM NAME]

6.4.3 When appropriate, the program name will be followed by an ~~em~~ dash and the field of study.

E.g. Bachelor of Music in Jazz Studies – Education.

6.5 Concentrations, Minors and Majors

6.5.1 Credentials that are accompanied by a concentration, minor or major will be named as follows:

6.5.2 Bachelor of [PROGRAM NAME] with a [CONCENTRATION, MINOR or MAJOR] in

[CONCENTRATION, MINOR or MAJOR].

E.g. Bachelor of Business Administration with a Concentration in Human Relations.

6.6 Post-Baccalaureate Certificates and Diplomas

6.6.1 Credentials of this type will be named as follows:

- 19/13** It is recommended that Senate approve the replacement of HKIN 275 with HKIN 191 as an acceptable pre-requisite for BIOL 240 – Pathology.
- 19/14** The course equivalency status of BADM 106 and BTEC 252, as well as Cap Core designation under the heading of *Self and Society* for BTEC 252, be recommended to Senate for approval.
