FNLG 106 The Squamish Language III (Skwxwu7mesh Snichim III) and FNLG 107 The Squamish Language IV (Skwxwu7mesh Snichim IV) are two new elective courses designed to increase the number of language contact hours to promote fluency.

The Squamish Nation Language and Culture Certificate program profile is being revised to indicate the addition of the two new electives, FNLG 106 and FNLG 107, and the addition of two existing courses, ANTH 202 and BIOL 104, to the list of electives.

SCC was requested to approve changing ESLF courses to EAP courses in terms of subject codes, numbers and names. These changes will ensure that all courses lead up to the capstone courses, EAP 100 and 101. The changes also affected the subject codes and numbers of the pre-requisites for each course, including EAP 100 and EAP 101.

SCC was also requested to change the prerequisite for the new EAP 099 to EAP 080 from the former ESLF 070. This will allow students at the new EAP 090-101 levels take this course as needed for additional reading and writing support. It is anticipated that instructors across the curriculum will recommend this course for at risk EAP students taking 100 level courses.

During the review of EAP 080 English for Academic Purposes 2 and EAP 090 English for Academic Purposes 3, concern was expressed on the necessity of both EAP 090 and EAP 099 listed for the recommended follow-up courses. It was determined that EAP 099 would act as a support course; however, after discussion, it was recommended to remove the reference to EAP 099 for both EAP 080 and EAP 090.

Jennifer Moore moved and Debbie Jamison seconded that:

Reference was made to a discussion from the December 14, 2012 SCC meeting wherein the issue of programs deciding whether EAP 100 English for Academic Purposes 4A and EAP 101 English for Academic Purposes 4B could be used as elective credits towards certificates, diplomas and degrees. Members were reminded that the default is that EAP 100 and 101 will count as lower level academic electives.

EDUC 476 Studio Research in ECCE: The Practices of Artistic Inquiry is a new course that will allow students more in-depth investigation of the practices and process of artistic inquiry in a pedagogical setting.
