PSYC 101 – Introduction to Psychology II is being revised to remove PSYC 100 as a pre-requisite.

PSYC 200 – Social Psychology, PSYC 203 – History of Psychology, PSYC 204 – Child Development, PSYC 215 – The Psychology of Human Sexuality, PSYC 220 – Theories of Personality are being revised to indicate either PSYC 100 or 101 as prerequisites and these changes will be reflected in the course notes.

PSYC 213 – Statistical Methods in Psychology is being revised to add MATH 123 as a pre-requisite option, along with PSYC 100 and 101.

The revisions will enable students to begin their studies in psychology with either PSYC 100 or 101. This will better align with Provincial trends and improve student access to both introductory and upper level psychology classes.

It was noted that the proposed changes will not affect the program profile for the Associate of Arts – Psychology degree as both PSYC 100 and 101 will remain requirements for the completion of the credential.
