### COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams. May be offered online or in mixed mode format.

### CALENDAR DESCRIPTION

This course is designed to be of special interest to designers, managers, and operators of business processes. The student will be able to apply the principles and practices of contemporary operations management in various functions of businesses involved in the production of goods and services. The content includes topics such as measuring performance in operations and value chains, quantitative aspects of project management, Inventory management, Goods and Service Design, Quality, Statistical process control, Operations Scheduling and Sequencing.

## COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

1. Assess appropriate communication tools and develop a professional report on an operations management topic such as Statistical Process Control, Project Management, and Resource Management.
2. Test theories of Operations Management to identify opportunities and make appropriate decisions for planning and improving capacity, productivity, quality, scheduling and job sequencing, and inventory management.
3. Apply relevant data for analysis and generate quantitative and statistical solutions using the appropriate models for various aspects of operation such as processes' quality, conformance, and capacity management, forecasting demand, and inventory management.
4. Describe the purposes of the main internationally recognized quality standards such as six sigma and TQM.
5. Identify and consider regional and global differences that can impact operations management decisions in value chains.
6. Recognize and account for the integrated aspects of all operations management techniques in their relationship to the organization and society such as the decisions on outsourcing, offshoring, and sustainability of operations.

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:
