COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams. May be delivered as mixed mode or online.

CALENDAR DESCRIPTION

The goal of this course is to cover the concepts and practices of computerized accounting using QuickBooks software. Topics will include system concepts, bank reconciliations, payroll services, projects, data entry processes, time system management, and report information representation for decision-making.

REQUIRED TEXTS AND/OR RESOURCES

Specific texts, resources and technology will vary depending on term and instructor. The course may make use of an assigned textbook, instructor prepared courseware or readings made available as Open Educational Resources (OER).

The software used in this course is QuickBooks.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

1. Develop an online accounting system for an organization.
2. Demonstrate the various accounting applications to record journal entries, cash, accounts receivable, and accounts payable for an organization.
3. Implement cost accounting principles to specific projects.
4. Calculate payroll using the time clock software and payroll feature to practice the payroll processing function for an organization.

5. Demonstrate the software bank reconciliation feature to practice the reconciliation functions for an organization.
6. Perform software taxes and payment features to practice internal software payment functions for an organization.
7. Analyze customized reports, in order to evaluate and provide recommendations in order to aid in the decision making of the organization.

- Data Entry Processes – 1 week
- Record Day-to-Day Transactions and Adjusting Entries - 2 weeks
- Activate Project Features for Service and Merchandising Companies - 2 weeks
- Time System Management - 1 week
- Payroll Service Management - 1 week
- Tax and Payment feature – 1 week
- Reports, Trial Balance Analysis, and Financial Statements - 2 weeks
- In-Class Assessments – 2 weeks

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:
