COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams. This course may be offered in mixed mode or online format.

COURSE PREREQUISITES

75 credits of 100-level or higher coursework including BFIN 347, ENGL 100, and CMNS 152 or 220

CALENDAR DESCRIPTION

The goal of this course is to introduce the topics that are traditionally deemed advanced accounting in nature in a manner that will prepare the students for their practice in accounting and in meeting the entrance requirements of professional accounting programs. Topics will include accounting for business combinations, foreign currency transactions and translations as well as accounting in the not-for-profit arena. (CPA transferable).

- 1. Evaluate, prepare and analyze financial statements including complex note disclosures for interim reporting and reportable segments in accordance with applicable standards.
- 2. Evaluate treatment for routine transactions for investments in associates/significant influence.
- 3. Evaluate treatment for non-routine transactions for business combination and consolidated statements on date of acquisition and subsequent to acquisition date.
- 4. Evaluate treatment for routine and non-routine foreign currency transactions, fair value and cash flow hedges.

5. Evaluate treatment for non-routine, not-for-profit transactions for fund accounting, capital assets, donated goods and services, contributions and restrictions.

- 6. Identify financial reporting needs for the public sector (government reporting) including unique concepts in the PSAB Handbook, internal and external users of government accounting information, and the objectives of government reporting and potential major reporting issues.
- 7. Integrate social and global perspectives into situational analysis and decision making, through understanding the dimensions of social impact on various business situations.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting
