## COURSE FORMAT

Three hours of class time, two lab hours plus an additional hour delivered through on-line or other activities for a 15 week semester, which includes two weeks for final exams.

One of the following: COMP 106 (C+), COMP 115 (C+), Pre-calculus 12 (A), Foundations of Mathematics 12 (A), Computer Science 12 (A), or MATH 105 (C-)

## CALENDAR DESCRIPTION

An introduction to computational techniques applied to Engineering problems. The primary focus of the course is on computer systems, the development of algorithms, and computer program design, implementation, and testing. The course also exposes students to the wider discipline of computer science, with topics including computer hardware and software, representation and manipulation of data, numerical analysis, and device interfaces.

## **COURSE STUDENT LEARNING OUTCOMES**

**On successful completion of this course, students will be able to do the following:**

- Apply problem-solving skills by developing algorithms and implement them in a structured programming language;
- Demonstrate a working knowledge of the C programming language;
- Design algorithms and programs using the principles of procedural abstraction and top-down design;
- Describe how digital data is internally represented, stored, and manipulated in a machine;
- Utilize common techniques for reading and processing raw data from a variety of sources;
- Solve a variety of common program design, computational, testing and debugging problems;
- Use off-the-shelf application software to perform some basic data manipulation and analysis;
- Develop a control program for an external device through a defined hardware interface.

**Students who complete this Numeracy course will be able to do the following:**

- Apply both analytical and numerical skills to solve problems;
- Summarize and analyze data in quantitative forms;
- Interpret and draw conclusions from an analysis of quantitative data;
- Represent quantitative information in a variety of forms (e.g. symbolically, visually, numerically, and verbally);
- Incorporate quantitative evidence in support of an argument.

**Students who complete this Science and Technology course will be able to do the following:**

- Apply numerical and computational strategies to solve problems;
- Evaluate scientific information (e.g., distinguish primary and secondary sources, assess credibility and validity of information);
- Demonstrate how a problem, concept, or process can be modelled numerically, graphically, or algorithmically;
- Explain how scientific inquiry is based on investigation of evidence and evolves based on new findings;
- Participate in scientific inquiry and communicate the elements of the process, including making careful and systematic observations, developing and testing a hypothesis, analyzing evidence, and interpreting results.

2	Final Exam Period (weeks 14 and 15)

**Incomplete Grades**

Grades of Incomplete "I" are assigned only in exceptional circumstances when a student requests extra time to complete their coursework. Such agreements are made only at the request of the student, who is responsible to determine from the instructor the outstanding requirements of the course.

**Late Assignments**

The due dates for all course activities are posted on eLearn. If you anticipate being late with a submission, please consult with your instructor beforehand.

Most deadlines will be at midnight. Late assignments will be penalized 10% if submitted before 8:30 am the following morning, then 20% for each succeeding day until solutions are available, and will not be accepted thereafter.

**Missed Exams/Quizzes/Labs/etc.**

Normally, a score of zero will be given for a missed exam, test, quiz, lab, etc. In some exceptional situations, the student will be permitted to write a make-up test, defer the lab to a later date or to replace the score by other marks.

The situations in which a score of zero may be avoided are those for which the student meets all of the following conditions:

1. Circumstances clearly beyond the control of the student caused the exam, test, quiz, lab, etc. to be missed. Such circumstances include serious illness or injury, or death of close family member. They do not include forgetting about the test, lack of preparation for the test, work-related or social obligations.
2. The student has notified the instructor (or the School of STEM office staff, if the instructor is not available) about the missed exam, test, quiz, lab, etc. Such notification must occur in advance, if possible, or at the latest, on the day of the exam, test, quiz, lab, etc.
3. Proof of the circumstances is provided. Proper proof of illness or injury requires a medical certificate from a doctor, who may also be consulted.
4. The student has been fully participating in the course up until the circumstances that prevented the writing of the exam, test, quiz, lab, etc. Fully participating means attending almost all of the classes and turning in almost all assignments in the course.

The options offered to the student who meets the four conditions are decided by the instructor. They will not necessarily meet the convenience of the student.

**Attendance**

Students are expected to attend and fully participate in all classes, labs and associated activities. Students are responsible for all information given during lectures, labs and tutorials, including exam dates and assignment deadlines, even if they were unable to attend for any reason.

**English Usage**

Students are expected to proofread all written work for any grammatical, spelling and stylistic errors. Instructors may deduct marks for incorrect grammar and spelling in written assignments.

**Electronic Devices**

Students may use electronic devices during class solely for class-related activities, such as note-taking, coding, and 'just in time' research to contribute to class discussions.

- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
