### **COURSE FORMAT**

Three hours of class time, plus an additional hour delivered through online or other activities for a 15-week semester, which includes two weeks for final exams.

### **CALENDAR DESCRIPTION**

This is an intensive workshop in writing literature for children of various ages. Students will work on such forms as text for picture books, poetry and nonsense rhymes, and chapters of young adult novels. Critically examining gendered and settler colonial biases that have historically shaped creative writing workshops and the field of children's literature, students will respond to diverse artistic voices on their own terms and manifest self-awareness about their positionality as it relates to the learning environment and the kinds of children's literature they produce.

### **COURSE NOTE**

ENGL 292 is an approved Culture and Creative Expression course for Cap Core requirements. For the focus of the course each term, see the "Courses" page on the English Department website. ENGL 218 is recommended.

### **REQUIRED TEXTS AND/OR RESOURCES**

A selection of picture books, children's poetry and prose, and YA (young adult) novels, along with critical and scholarly readings. The course may make use of a published anthology or coursepack. Specific texts will vary depending on the instructor and term.

### **COURSE STUDENT LEARNING OUTCOMES**

**On successful completion of this course, students will be able to do the following:**

1. Employ editorial vocabulary specific to children's literature in the analysis and critique of student writing and literature through oral and written communication and collaboration.
2. Produce diverse forms of children's literature which operate in relation to community, history, and citizenship.
3. Engage in creative processes including conception, investigation, writing, and critique (from drafting, to workshopping, to portfolio).
4. Interpret diverse children's literary forms from multiple perspectives (e.g. artistic, historical, political, literary, scientific, theoretical, multi-lingual).
5. Demonstrate the connection between forms of children's literature and the ideas, traditions, and belief systems they engage.
6. Recognize the limited, exclusionary, and colonial nature of the literary canon and traditional workshop model. Attend to the important work that has been done to critique, expand, and diversify the canon and traditional workshop model.
7. Examine literary traditions and the influence of systemic racism, colonization, and heteropatriarchal power structures in shaping literary cultures.
8. Curate a professional written portfolio.

**Students who complete this Culture and Creative Expression course will be able to do the following:**

1. Engage in creative processes including conception, investigation, execution, and ongoing critical analysis.
2. Identify, analyze, and critique the elements of a form of expression using its specific vocabulary.
3. Explain or demonstrate the connection between various events, ideas, traditions, and belief systems and the modes in which they are artistically or culturally expressed.
4. Interpret diverse forms of creative expression from different perspectives (e.g. artistic, historical, Indigenous, literary, scientific, philosophical).

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:
