## COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

## COURSE PREREQUISITES

45 credits of 100-level or higher coursework.

## CALENDAR DESCRIPTION

This course examines contemporary, cross-cultural queer cinema in the mainstream studio, independent and international film industries and the relationship between queer cinema and the global film communities.

## COURSE NOTE

FILM 323 is an approved Culture and Creative Expression course for Cap Core requirements.

## REQUIRED TEXTS AND/OR RESOURCES

All readings will be provided by the instructors. Readings and video links will be accessible on Moodle, and most films will be available at the Capilano University Library. Students may be required to purchase or rent some film titles.

## COURSE STUDENT LEARNING OUTCOMES

**On successful completion of this course, students will be able to do the following:**

1. Define queer cinema in relationship to contemporary global film industries
2. Analyze central critical themes in queer cinema studies including genre, gender, identity, race, politics and class
3. Describe the evolution of queer cinema in a historical context
4. Identify influential queer films and filmmakers

**Students who complete this Culture and Creative Expression course will be able to do the following:**

1. Engage in creative processes including conception, investigation, execution, and ongoing critical analysis;
2. Identify, analyze, and critique the elements of a form of expression using its specific vocabulary;
3. Explain or demonstrate the connection between various events, ideas, traditions, and belief systems and the modes in which they are artistically or culturally expressed;
4. Interpret diverse forms of creative expression from different perspectives (e.g. artistic, historical, Indigenous, literary, scientific, philosophical).
5. Explain the significance of diverse forms of human creative expression, specifically including indigenous forms.

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
