COURSE FORMAT

Two lecture and one instructor-led lab hours per week for a 15 week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION

This course focuses on acquiring the skills to "translate" music from the audible to the written or from the written to the audible, utilizing the singing voice as a tool for clarifying, verifying, internalizing and communicating musical thought. Students will learn to sing, sight sing, and take dictation involving basic musical materials including simple diatonic melodies in major and minor keys, harmonic progressions including diatonic triads and inversions, and rhythms in common time signatures.

- take dictation of harmonic progressions including diatonic triads in all inversions;
- take dictation of rhythmic events in common time signatures;
- sing or sight-sing all melodic, rhythmic and harmonic content of the course;
- understand the importance of aural skills and the integral relationship of those skills to music performance and composition;
- demonstrate attention to detail and show evidence of the personal study habits and work ethic critical for professional success.
