#### **COURSE FORMAT**

## **COURSE PREREQUISITE**

JAZZ 275 with a grade of C- or higher

### CALENDAR DESCRIPTION

The course introduces students to the methods of ethnomusicology with an emphasis on musical cultures outside of Western Europe. The course will include the description of characteristic musical attributes for various cultural regions as well as the application of ethnomusicological concepts to individual musical contexts.

## **Evaluation Details:**

- Exams: There will be one two-hour midterm exam and one final three-hour exam. The midterm will focus on introductory material, Africa, and India. The final exam will be cumulative. Test format will be short essays, multiple choice, descriptions and definitions of certain terms, listing of facts, as well as short objective questions. The midterm and the final exam will include a listening component.
- **Concert Report:** Students will attend a live music concert that features music from outside their own culture and write a 500-750 word report.
- **Group Presentation:** Students will be placed in a small group and research and create a short (10-20 minutes) group "performance" connected to one of the music cultures examined in the course.
- **Professional Behaviour:** Punctuality and regular attendance are required at all classes. To receive full marks in this area, full participation in all class activities is expected, as is respectful behaviour towards fellow students and the instructor. Students who do not meet these standards may be advised to drop the course and consider re-taking it in the future when they are able to commit to it more appropriately.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
