COURSE FORMAT: 4 instructional hours, plus two tutorial hours per week for a 15-week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION

This course is a continuation of MUTH 370, and will enable Musical Theatre students to further continue the progress of their skill development to the advanced level. Students will be expected to recognize and execute advanced level dance skills in the areas of ballet, jazz and tap. Through weekly technique classes, students will be assessed for individual progress. An audition format will be introduced this year, which will prepare students for the dance auditions that each will encounter upon graduation from this program. In this term, Ballet and freestyle auditions will be added to the Jazz and Tap auditions from last term.

COURSE STUDENT LEARNING OUTCOMES

Upon successful completion of this course students will be able to:

- Execute more advanced techniques building on the ballet, jazz, and tap vocabulary learned in MUTH 170, 171, 270 and 271;
- Integrate body awareness required to perform more advanced technical moves;
- Recognize and identify dance disciplines which are relevant (culturally, historically, environmentally) to the Musical Theatre genre;
- Reflect critically and with broader perspective on dance styles, content and interpretation;

• Confidently utilize appropriate techniques for auditioning and quick pick-up of choreography;

• Create and integrate advanced elements of choreography based on a set theme or style in a group environment;

• Collaborate in dance and storytelling through group repertoire.

ASSIGNMENTS

1.Execution of dance techniques: Students will be expected to execute intermediate to advanced level dance skills with control and proficiency.

2.Dance Auditions: There will be a minimum of 4 to a maximum of 5 dance auditions during the term. These will be based on current industry audition formats, which will include demonstrations of combinations in various dance disciplines. Students will be expected to perform those combinations with confidence and accuracy. Guest instructors may also be present. Audition techniques will also be assessed.

3.Ensemble Choreography: At the end of the term, students will present 2-3 choreographed ensemble dance pieces. Students will be assessed on dance techniques, integration of performance skills, accuracy, and ease of execution. Some material may be integrated into the capstone project/graduation showcase.

4.Professional Behaviour: Students will receive a mid-term progress report based on the outcomes listed in the Theatre Department Standards for Professional Behaviour. In addition to forming part of the grade for this course, the end-of-term Professional Behaviour Reports are reviewed by the Theatre Department audition committees.

- Copying or attempting to copy the work of another during an assessment;

- Using unauthorized aids, notes, or electronic devices or means during an examination;

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,

Program Operational Details

Class Participation

Students must come prepared to contribute to all activities in a positive focused manner.

Outside Productions

Involvement in outside productions during the term affects a student's level of commitment and the quality of program work. The quality and pedagogy of outside productions cannot be guaranteed and may be detrimental to the progress of the student. For these reasons, the Theatre Department will not permit students to be involved with productions, which are not officially part of the program. Students who engage in outside productions will receive 0 for Professional Behaviour and may be asked to leave the program.

Theatre Department: Standards for Professional Behaviour

Capilano University has established policies on academic integrity and on sexual violence and misconduct, which include harassment and bullying. The Theatre department upholds those policies and declares that bullying and harassment of anyone at the University and in the greater community will not be tolerated. Bullying is described as behaviour that is intended to undermine, humiliate, or hurt someone. The following outcomes are a graded requirement in all of our department courses. They are based on industry standards and are intended to prepare the student for professional work. Students will receive mid-term progress reports and these are reviewed at the end of the year by the department audition committee.

1. Outcome: Creative Integrity

Measurement Criteria: The student values

- the willingness to do exercises and/or take direction designed to increase the boundaries of known skills;
- commitment by participating in rigorous rehearsal and performance activities without sacrificing class and studio work;
- self-motivation by integrating and applying knowledge from all disciplines studied;
- creativity by bringing new ideas to the ensemble.

2. Outcome: Good Work habits

Measurement Criteria: The student manages

• punctuality, regular attendance, proper attire - this will be determined by the instructor and be dependent on the requirements of the class;

• preparation for the task by arriving with expected equipment/material, active listening skills, effective note taking and rehearsal notation. The use of electronic devices in the classroom is allowed with instructor's approval only.

3. Outcome: The Ability to work in instructor led as well as collaborative situations

Measurement Criteria: The student values

- respect for leadership and community;
- an awareness of the protocol of industry standards;
- the procedure for conflict resolution.

4. Outcome: Ability to Work in ensemble groups

Measurement Criteria: The student connects with others through

- verbal or nonverbal encouragement and support for each other's work and ideas while recognizing contributions to the group;
- exhibiting leadership by proposing goals and tasks, initiating discussion and keeping the group focussed while leading by example;
- sensitivity to stigmas, multiculturalism, gender, indigenous practices, sexual orientation, age, place of origin or religious affiliation.

5. Outcome: Successful Time Management

Measurement Criteria: The student

- reads and follows schedules and meets deadlines as required;
- respects the time of others by attending scheduled appointments, meetings and rehearsals.

6. Outcome: Self-awareness, Self-care, Self-learning

Measurement Criteria: The student

- navigates internal and external factors in one's personal life and how they can affect professional performance;
- is mindful of personal hygiene and physical and mental well-being;
- is aware of gaps in their development and takes steps to mitigate them;
- is able to accept, evaluate and respond appropriately to professional criticism.

7. Outcome: Ethical Standards

Measurement Criteria: The student is eager to show

- honesty, empathy and accountability;
- integrity and commitment;
- reciprocity (generosity in relationships);
- respect for the community and the privacy and confidentiality of others.

8. Outcome: Compliance with Safety Regulations and Respect of Work Space, Equipment & Materials

This refers to technical equipment associated with theatre and film production as well as

classroom materials, masks, costumes, set pieces and properties. It also refers to the Performing Arts Theatre, shop spaces and Rehearsal Hall, The Arbutus Studio, and their immediate environments.

Measurement Criteria: The student understands and

- complies with all safety regulations in the workplace by following instructions on the use of equipment and materials;
- acknowledges the value of all equipment by learning the safe operation of equipment;
- shows responsibility by locking up appropriate equipment, returning all borrowed material and helping to keep the workspace safe and clean;
- respects the department policies on food and beverages:

"Food and beverages are not allowed in the Performing Arts Theatre, in the rehearsal hall or Arbutus Studio. Water bottles are permitted. Occasionally, with permission of a stage manager, other beverages in closed containers may be allowed in rehearsals. These spaces are not to be used as lunchrooms."
