**COURSE FORMAT:** 3 hours lecture per week for 15 weeks, plus fourth hour activities **PREREQUISITES:** 75 credits of 100 level or higher coursework, including TOUR208

FOURTH HOUR: Fourth hour activities for this course may include on-line instruction, small group meetings with

faculty, tutorials, field trips, or industry events.

COURSE DESCRIPTION:

This course focuses on increasing the student's knowledge of legal issues facing adventure tourism businesses, sports organizers, recreationalists, spectators, and recreation facilities.

Students will develop knowledge of how various areas of the law impacts the adventure tourism

industry, and will include both civil and criminal matters, administrative law, and risk

management.

By the end of this course students should be able to analyze and understand the impact of applicable Canadian Laws on adventure tourism business ventures. Students will be introduced to relevant B.C. and Federal statute law as well as applicable judge-made law. The rights and potential liabilities of the various parties in adventure tourism business relationships will also be

discussed.

### **COURSE LEARNING OUTCOMES:**

### **LEARNING OUTCOMES**

- 1. Differentiate the various categories of law as they apply to the Canadian common law system and understand how they impact adventure tourism business ventures.
- 2. Understand basic steps in the Canadian, and in particular the B.C., court systems.
- 3. Identify torts and explain their impact on adventure tourism business ventures.
- 4. Apply the principles of enforceable contract and assess the impact of both statute and judge-made law on adventure business contracts.
- 5. Recognize and analyze specific contracts such as employment contracts, agency contracts, leases, e-commerce contracts, and waivers of liability.
- 6. Categorize the methods of protecting intellectual property, and more specifically, adventure business ideas, names and logos.
- 7. Explain the advantages and disadvantages of the three legal forms of business organization, and when it is appropriate to use other structures such as societies and cooperatives.
- 8. Understand how the above factors fit into an overall risk management program for an adventure business venture.

#### **FACULTY POLICIES:**

# Attendance:

Regular class attendance, and participation in course activities and assignments, is expected and likely essential to successfully achieving the course learning outcomes. Students are responsible for any and all content and instructions communicated during scheduled classes, in course handouts, and (if applicable) via course email and web sites. In cases where participation by all students is essential for conducting the planned instructional activities, attendance may be mandatory. In all cases, the attendance expectations and any penalties for missing instructional activities shall be clearly articulated on the course outline.

#### Attendance for weekend courses is mandatory.

No exemption from class time will be granted without appropriate medical documents or a proven emergency. Should a student choose to be absent they will receive a 15% deduction off the total final grade in the course for any day/or portion thereof missed. Students are required to make up all class work for which they were not in attendance.

# Professional Behaviour:

Students must demonstrate a professional attitude and behaviour toward work, fellow students and their instructors. # Cheating and Plagiarism:

Cheating is an act of deceit, fraud, distortion of the truth, or improper use of another person's effort to obtain an academic advantage. Cheating includes permitting another person to use one's work as their own. Plagiarism is the presentation of another person's work or ideas as if they were one's own. Plagiarism is both dishonest and a rejection of the principles of scholarship. # Penalties for Cheating and Plagiarism:

A grade of '0' for an examination, quiz or assignment or 'F' for the course may be assigned if cheating or plagiarism has taken place.
