COURSE FORMAT: Two hours of class time per week for a 15-week semester, which includes two weeks for final exams.

COURSE PREREQUISITES: ASAS 115 and ENGL 100

CALENDAR DESCRIPTION: Students will continue to strengthen their voices through intensive training and exercise. An intermediate regimen of training will be introduced and reinforced throughout this term.

COURSE NOTE: For Acting for Stage and Screen program students only.

REQUIRED TEXTS AND/OR RESOURCES: Required texts and/or readings will vary by the instructor. They may include articles, diagrams, and scripts.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- evaluate student's past work in addressing vocal habits
- interpret and modify their ongoing training to suit self-identified needs
- organize their reflective statements into a critique of their work
- participate in an emergent curriculum and engage in an ensemble-directed training
- combine the knowledge and competence found in vocal training with their performance

COURSE CONTENT

The content and week-by-week breakdown of the course will vary by term and instructor. The following is a sample:

ASSIGNMENTS: The assignment structure for this course is determined by the instructor in accordance with the learning outcomes outlined above. Please refer to the course syllabus and eLearn site for a more detailed breakdown.

Reflection Assignments: Students will be required to write reflective responses to aid in the recognition of personal habits, progress, observations of the work and breakthroughs in the training process. This may include but is not limited to short essays, responses to a specific topic, or a journal.

In-Class Skills: Students will be evaluated on their progress and internalization of their vocal training as observed in class over the course of the semester. Different exercises will present different challenges to different students. As the semester progresses, students have the opportunity to develop their skills in training and apply them by addressing individual goals.

Major Projects: Over the course of the semester, students will complete one or more major projects to demonstrate their progress in their vocal work. This may include but is not limited to text projects, where individual students use text to apply their vocal training and present this in class or to the instructor, and ensemble projects, where groups of students work together on an assigned text or other vocal project. Major projects may also include specific assessments at key times in the semester, such as a Mid-Term assessment and an End of Term assessment. Details will be reviewed in class by instructor.

Professional Practices:

The grade reflects the departments Professional Practices document as laid out in the Student Handbook and the syllabus. Professional Practices and expectations specific to this class will be reviewed by the instructor.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:
