## **COURSE FORMAT**

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

### CALENDAR DESCRIPTION

Students will discuss systemic inequities across issues such as gender, sexuality, race, class and disability, dialoguing about transformative change within the context of early years settings.

## COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- 1. Disrupt assumptions and dominant discourses around the concepts of difference, inclusion, social justice and equity.
- 2. Foster critical thinking with notions of ability, race, gender, class, among others.
- 3. Understand ableism, racism, classism, sexism, transphobia, homophobia, and other systems of oppression.
- 4. Discuss current social issues (for example, legacies of colonization, globalization, migration), considering systemic and historical perspectives and its current impacts in personal and collective positionalities.
- 5. Engage with the work of social justice and anti-oppression while considering its articulation within the early childhood studies field.
- 6. Develop capacity to engage with transformative change in work with families and early childhood educator.

# Students who complete this Self and Society course will be able to do the following:

- 1. Assess and evaluate individual and collective responsibilities within a diverse and interconnected global society.
- 2. Analyze the impact of colonialism and racism on Indigenous peoples.
- 3. Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change.
- 4. Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures.

# **COURSE CONTENT**

- Disrupting assumptions around the concepts of difference, inclusion, social justice and equity
- Family-centre practice and pedagogical relationship: engagement between families and early childhood educators
- Inclusive settings implications for practice (Thinking with the notions of disability, class, culture, race and gender)
- Hierarchies of difference and discourses of deficit

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating**: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

Fraud: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
