COURSE FORMAT

This course runs over a 15-week term consisting of 25 days off-campus practicum; there will be on-campus practicum seminars prior to the start of practicum and during practicum. All seminars are mandatory unless otherwise posted. Please note that failure to attend the first practicum seminar will result in a forfeiting of the practicum.

CALENDAR DESCRIPTION

The ECCE program includes three applied theory practicum courses. In each successive course, students extend their knowledge and skills developed in the previous practicum. This course is the third course in the sequence. Students will continue to develop skills in observing, documenting and understanding children and their play and develop programming that honours individual differences, family and cultural practices. During this practicum, the student will be expected to participate as a member of the teaching team.

COURSE NOTES

EDUC 277 is an approved Experiential course for the Cap Core requirements.

Prior to practicum placement, students must submit the following documentation in accordance with the Child Care Regulations: a resume, three references, criminal record check, medical report and TB test.

It is recommended but not required that students have some experience working with children (birth to 5 years of age) as an employee or volunteer.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

1. Implement daily play-based, inclusive experiences which promote the development of the whole child;
2. Conduct small and large group experiences plan and implement the practicum centre's program for two days;
3. Use a variety of guidance techniques in accordance with the needs of the individual child and the situation;
4. Support and extend children's play, learning, and development by:
 - a) Using a variety of teaching strategies such as observing, recording, questioning, provoking, negotiating, and facilitating
 - b) Planning across the curriculum
 - c) Arranging the environment
 - d) Defining limits and behavioural expectations
 - e) Maintaining appropriate routines and encouraging self-help skills
 - f) Providing materials and resources; and
5. Demonstrate interpersonal skills by:
 - a) Communicating effectively with mentor teacher, staff, and instructors;
 - b) Relating to parents, as appropriate to the role of student assistant in a particular centre.
6. Demonstrate an understanding of a reflective practice as understood in the BC Early Learning Framework in work with children, teachers, and instructors.

Students who complete this Experiential course will be able to do the following:

- Critically reflect on their progress and development in the context of the course and assess the utility of the acquired knowledge, skills, and values in the learner's personal, academic, or professional trajectory.
- Apply the skills and knowledge of a given discipline or professional context, including working collaboratively in both leadership and team roles.

COURSE CONTENT

The student will spend 25 days in a licensed early childhood centre arranged/approved by Capilano University. The dates of the practicum will be individually arranged within the practicum course dates.

Please note that in an attempt to assist with a student's success in practicum, the ECCE instructor will share with the mentor teacher any information about the student's previous practicum or progress in ECCE courses to date.

Individual interviews will be held with each student following the instructor's visits to the practicum centre. Students will be assisted to evaluate their own progress and to set realistic goals for their ongoing development as Early Childhood Educators.

EVALUATION PROFILE

This is a credit/no credit course. The evaluation profile consists of practicum assignments and practice competencies. Students must achieve a pass on all practicum assignments and practice competencies in order to receive credit for the course.

Details of assignments will be provided by the instructor at the start of the course.

All assignments must be submitted in order to complete the course and receive credit.

Attendance

Attendance is essential for the successful completion of this course and to meet the Licensing requirements of the BC Early Childhood Educator Registry. Punctuality is considered a part of attendance. If you are late or absent from more than 10% of classes you will not receive credit for this course. Please note that this pertains to all students taking this course, regardless of whether individual students are not seeking licensure.

Any missed days (including for illness) must be made up by the student. The rescheduling of days will be decided in consultation with the host centre and the advising faculty.

Attendance at all practicum seminars is mandatory. If a student is absent from any practicum seminar, this will result in a forfeiture of practicum.

Students must remain available throughout the full exam period; either for final exams or assignments. Students who are in courses that do not have final exams scheduled will have classes until the last day of the exam period. In rare circumstances, exams may need to be rescheduled due to harsh weather conditions or other unforeseen factors. Travel plans must be made outside of the exam schedule.

Punctuality

If a student is late more than twice to class or practicum, a faculty review will occur. Program probation may be a result of the review.

English Usage

Students are expected to proofread all written work for any grammatical, spelling, and stylistic errors. Instructors may deduct marks for incorrect grammar and spelling in written assignments. It is expected that APA referencing conventions are used for all ECCE assignments. All assignments are expected to adhere to APA stylistic guidelines for avoiding bias in language use and are to be written in a manner that reflects the spirit and values inherent in the ECEBC Code of Ethics and the BC Early Learning Framework.

Electronic Devices

Students are required to use digital cameras for practicum assignments with GPS tracking disabled. No cell phones are to be used for photo taking.
