#### **COURSE FORMAT**

Two hours of seminar each week for a 15-week semester, which includes two weeks for the final exam period; the course includes 6 hours of field placement weekly for 12 weeks.

## **CALENDAR DESCRIPTION**

This practicum course is focused on working with children and youth. Previous course material related to children is reviewed and integrated in this practicum, including normal child development and a range of clinical conditions found in children, and Developmental Music Therapy, Creative Music Therapy and Burke's MakeMusic approach. Students also reflect on their personal experiences of childhood and of working with children before entering the program, to assist them in creating their own unique therapeutic approaches and to heighten their awareness of their own and their clients' transference. Weekly seminars develop therapeutic awareness and clear written and interpersonal communication, and always include collegial sharing of effective approaches and clinical challenges and reflection.

- 5. Create effective relationships with supervisors, staff and clients;

- 6. Familiarize oneself with the operating structure of their placement;
- 7. Increase self-awareness as it is related to being a music therapist; and

8. Be transparent in making use of teachers, classmates and supervisors to discuss, reflect on and work through challenges and questions which are presented by the fieldwork experience.

## **COURSE CONTENT**

Students attend a practicum setting - one 6-hour day a week for 12 weeks – facilitating group and individual sessions, assessing new clients, documenting session notes, planning sessions and working with resource people as needed. Students will be supervised a minimum of 30 minutes each week. A seminar class occurs once a week for the term where students discuss their practicum experiences, network with others, problem-solve situations and present on their work

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
