COURSE FORMAT

Four hours of instruction, 2 hours tutorial per week for a 15-week semester, which includes two weeks for final exams.

This course is a continuation of MUTH 170 with more emphasis on the integration of performance tecniques.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Continue to develop an understanding of, and embody, body and spatial awareness, physical connection, posture and alignment, coordination and flexibility;
- Explore three of the dance disciplines which are relevant to the Musical Theatre genre;
- Reflect critically on the historic contexts and origins of various dance forms and their relevance to musical theatre;
- Apply methods of storytelling through dance using different styles of repertoire;
- Integrate musicality, technique and creative expression into individual and group dance work.

COURSE CONTENT

The content and week-by-week breakdown of the course will vary by term and instructor(s). The following is a sample.

1-2	Review skills from previous semester and set individual goals for this semester.	
3-6	Continue development of skills and choreography.	
7-9	Continue development of skills and choreography. Assignments and midterm assessments may be assigned.	
10-13	Continue development of skills and choreography.	
14-15	Final assessments and/or performances

ASSIGNMENTS

The assignment structure for this course is determined by the instructor in accordance with the learning outcomes outlined above. Please refer to the course syllabus and eLearn site for a more detailed break-down.

In-Class Skills: In class skills will be assessed for memorization; the ability to apply, self-assess and sustain corrections; physical awareness; musicianship; and/or knowledge of terminol-ogy. Skill assessments will happen at various points throughout the term.

Assignments: This course will have assignments such as tests, research projects, and/or reflective assignments demonstrating critical thinking on dance styles and/or historical dance content.

Ensemble Work: This course will have 2-3 ensemble compositions demonstrating the skills learned within this class. Retention of choreography, integration of dance and performance techniques and spatial formations and relationships will be assessed. Ensemble pieces may be performed at term end.

Final Assessment: Skills introduced throughout the term will be assessed in all disciplines. The ability of the student to integrate techniques into novel combinations may be assessed.

Professional Practices: This grade reflects the department's *Professional Practices* as outlined in the Student Handbook. Professional Practices and expectations specific to this class will be reviewed by the instructor.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
