CALENDAR DESCRIPTION

This course will enable Musical Theatre students to continue the progress of their skill development in dance. Students will explore industry ready techniques including preparing for vigorous dance rehearsals and performances. More audition experiences in a wide variety of styles/genres and formats will also be included.

For Musical Theatre program students only.

REQUIRED TEXTS AND/OR RESOURCES: Required texts and/or readings will vary by the instructor(s).

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Sustain body and spatial awareness, physical connection, posture and alignment, coordination and flexibility within more advanced dance vocabulary;
- Learn, retain and execute choreography with increased speed and accuracy;
- Apply a variety of audition skills in a dance audition setting;
- Critically reflect, value and implement perspectives on the origins, contexts and interpretations of a variety of dance styles and their relevance to musical theatre;
- Utilize audition strategies in a variety of dance audition formats;
- Integrate musicality, technique and creative expression into solo, partner and group dance work in rehearsals and auditions;

• Use self-reflection to implement training strategies.

COURSE CONTENT

The content and week-by-week breakdown of the course will vary by term and instructor(s). The following is a sample.

ASSIGNMENTS:

The assignment structure for this course is determined by the instructor in accordance with the learning outcomes outlined above. Please refer to the course syllabus and eLearn site for a more detailed breakdown.

In-Class Skills: In class skills will be assessed for memorization; ensemble work; the ability to apply, self-assess and sustain corrections; physical awareness; integration of style; authenticity; musicianship; and/or knowledge of terminology. Skill assessments will happen at various points throughout the term.

Mock Auditions: There will be 2-3 mock auditions during the term.

These will be in a professional audition format in which the instructors will assign a different show or style of dance for each audition. Students will be expected to research and prepare for the appropriate show/style, learn demonstrated combinations quickly and integrate dance, audition and performance techniques. A guest panel from the professional industry may be present.

Assignment: Reflective work that shows the students ability to create and implement improvement strategies. This could take the form of a self-reflection, written assignment or physical demonstration.

Professional Practices:

The grade reflects the departments Professional Practices document as laid out in the Student Handbook and the syllabus. Professional Practices and expectations specific to this class will be reviewed by the instructor.

research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.
