CALENDAR DESCRIPTION

Retail is a dynamic and fast-paced environment where promotion, marketing and merchandise decisions affect the profitability of an organization. In this course, students will examine both in-store and digital retail merchandising and the focus will be on the various types of operations that will affect a retailer's competitiveness and profitability.

COURSE STUDENT LEARNING OUTCOMES

1. Define and apply the principals and strategies of planning merchandise assortments. Including retail math for pricing decisions, sourcing, inventory cost and markdowns.
2. Explain how retailers communicate with customers and build brand awareness using integrated marketing and communication process.
3. Explain how merchandising operations are executed in retail organizations and how it impacts profit margin.
4. Recall basic retail marketing and communication concepts, the impact that branding has on marketing, how to use marketing information to enhance sales, how to identify a target market, and how to create a marketing plan
5. Explain how merchandise is obtained and managed, its movement through the supply chain, how it's merchandised on the sales floor, and how technology helps tracks inventory.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:
