BIOL 412 – Neurological Damage, Disease and Degeneration *Presented by: Tom Flower* 

BIOL 412 – Neurological Damage, Disease and Degeneration is a new 3-credit course that will support the 400-level training for students in the BSc General degree program, with an emphasis on students within the Biomedical Sciences concentration. BIOL 412 represents one of STEM's first 400-level course

The prerequisites for the three courses are being revised to make the courses more accessible to a broader range of students and to bring the courses in line with most upper-level courses in the Faculty of Arts and Sciences, as follows:

- PHIL 302 Knowledge and Truth:
  - From "45 credits of 100-level or higher coursework including PHIL 102 and 3 additional credits of 100 or 200-level PHIL" to "45 credits of 100-level or higher coursework"
- PHIL 320 Philosophy of Science:
  - From "45 credits of 100-level or higher coursework including 6 credits of 100 or 200-level" to "45 credits of 100-level or higher coursework"

#### 6. MOPA

Bachelor of Motion Picture Arts

Presented by: Michael Thoma and Andrea Klipp

Currently, the basic Admission requirements for the Bachelor of Motion Picture Arts (BMPA) program include English Studies 12 or English 12 or English First Peoples 12 or equivalent and a minimum average of 75% in all Grade 12 high school courses. However, the inclusion of all Grade 12 high school courses may provide a less accurate measure of academic proficiency. In this regard, the following revisions were requested for the BMPA:

- Admission Requirements:
  - From "English Studies 12 or English 12 or English First Peoples 12 or equivalent and a minimum average of 75% on all Grade 12 high school courses" to "English Studies 12 or English 12 or English First Peoples 12 or equivalent and a minimum average of 75% on two Grade 12 high school academic courses"
- Admission Notes:
  - From "For selected applicants, an interview will take place with a panel
    of two faculty members. Admission is competitive and only the most
    qualified applicants will be invited to an interview."
  - "For selected applicants, there will be a mandatory group session with faculty members. Online synchronous sessions may be provided for exceptional circumstances."

On discussion, it was suggested that the language under Continuation Requirements be clarified in the second bullet as follows:

The School of Legal Studies developed a Citation in Contract Law at the request of BC Hydro in 2017. In the fall of 2022, Capilano was approached to create a Certificate in Contract Law for BC Hydro managers and/or employees who wish to continue their legal training.

The general objective is to provide instruction to BC Hydro managers involved in contract negotiations and management so that they will have a better understanding of the legal rights and obligations associated with contracts. The desired outcome is that this will lead to better outcomes in contract management and dispute resolution for BC Hydro.

The new Certificate will be comprised of the three courses offered in the Citation in Contract Law (9 credits consisting of LAW 101 – Introduction to Law, LAW 300 – Contracts I, and LAW 301 – Contracts II) and adds the following existing additional five courses:

- LAW 200 Torts I
- LAW 201 Torts II
- LAW 310 Legal Drafting
- LAW 331 Indigenous People and the Law
- LAW 440 Real Property

The Certificate in Contract Law will eventually be offered to interested corporations in addition to BC Hydro.
