### **COURSE FORMAT**

Varies according to the project, but follows the normal schedule for rehearsing and producing a play. Approximately 60 hours over a 15 week term.

**COURSE PREREQUISITES:** ASAS 161 and ENGL 100

**CALENDAR DESCRIPTION:** This course acknowledges the theatre skills which are learned during rehearsals and practical work on productions. Students in the Acting for Stage and Screen program will take part in a bare bones production of a play, which will be performed in the Arbutus Studio at the end of term.

**COURSE NOTES:** For Acting for Stage and Screen program student only.

**REQUIRED TEXTS AND/OR RESOURCES:** A script for the production will provided by the instructor.

# **COURSE STUDENT LEARNING OUTCOMES:**

On successful completion of this course, students will be able to do the following:

- Apply and integrate elements of acting, voice and movement in performance;
- Analyze scripts and prepare an actor's book that reflects their choice of acting process;
- Create a performance which reflects a well-developed understanding of the play's given circumstances, character objective and motivation;
- Practice self-awareness, integrity, collaboration and problem-solving skills in individual and group settings.

#### **COURSE CONTENT:**

This performance course will consist of rehearsing a play over the semester. Students will learn blocking, character analysis, vocal and physical embodiment and performance skills. The content and week-by-week breakdown of the course will vary by term and instructor(s). The following is a sample.

2 - 13	Rehearsals, blocking and character work for performance.	
14/15	Studio performance	

#### **EVALUATION PROFILE:**

Students will be evaluated on their commitment to the weekly rehearsals, for their creative contributions to the ensemble and their growth from the beginning of rehearsals to the performances at the end of term. An example of the assignments is listed below.

#### **ASSIGNMENTS:**

- 1. Script Interpretation: Students will use the given circumstances of the text to develop character objective and motivation for the play.
- 2. Actor's book: This will show the students' preparation, process, and reflective practice for preparing for performance.
- 3. Vocal and Physical Embodiment of Character: Students will use skills learned in voice, movement and PTI, in collaboration with the director to create a fully realized performance.
- 4. Performance: Students will be assessed during the performance run for consistent character portrayal and successful collaboration with the ensemble.
- 5. Professional Practices: The grade reflects the departments Professional Practices document as laid out in the Student Handbook and the syllabus. Professional Practices and expectations specific to this class will be reviewed by the instructor.

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating**: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

Fraud: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

• Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);

- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.
