COURSE DESCRIPTION:

The dissertation is an independent and original piece of work incorporating research, study and evaluation. It is the culmination of a successful graduate programme, demonstrating the student's ability to work independently. The dissertation may focus on any aspect of the International Management Graduate Diploma programme. Each student will be allocated a supervisor, who must finally approve the topic. In all cases, the research must demonstrate critical and independent thought. Each student will also be allocated a primary and secondary individual dissertation supervisor, whose roles will be to offer guidance and support during the dissertation process to ensure the learning objectives are achieved in each individual case.

REQUIRED TEXT and OTHER RESOURCES:

No required text. Students will use their resource materials from INMA 520 Graduate Research Methodology course. A dissertation handbook will be available to all students to act as a focus and guide for the dissertation process.

COURSE FORMAT:

Online course work as well as advisory review meetings with faculty on average of 8 hours per week, over a 15 week period.

The course website on Moodle will provide a detailed schedule of activities, deliverables and updates.

Students are REQUIRED to check the course web site on Moodle as well as his/her name@capilanou.ca email at least 3 times weekly as these are the primary vehicles for university correspondence between instructor and student. Course communication will not be sent to student personal emails.

COURSE OUTCOMES:

The aims of this course are to enable students to:

- carry out an independent and original piece of academic research on a specific topic related to international business:
- define an appropriate set of aims and objectives and carry them through to completion;
- devise and apply an appropriate methodology;
- underpin the research with an appropriate literature review;
- exercise critical analysis and judgment throughout, including in the literature review, the selection of relevant data, interpretation of findings and synthesis of conclusions;
- present the research as a report to a high quality professional standard, with appropriate, contents pages, executive summary, figures and tables, bibliography and appendices.

EVALUATION PROFILE:

The dissertation is an independent and original piece of work incorporating research, study and evaluation. It is the culmination of a successful international post graduate programme, demonstrating your ability to work independently. It is underpinned by a formal teaching programme of Research Methods offered in the first term of study.

The dissertation may focus on any aspect of the international post graduate business programme. Each student will be allocated a supervisor, who must finally approve the topic. In all cases, the research must demonstrate critical and independent thought.

A dissertation handbook will be available to all students to act as a focus and guide for the dissertation process. Each student will also be allocated two individual dissertation supervisors, one from Capilano University and one from Hertfordshire whose role will be to offer guidance and support during the dissertation process to ensure the learning objectives are achieved in each individual case.

Management of the research strategy, development and application of research techniques and skills are assessed both formatively and summatively. Formative assessment is undertaken by the supervisor through discussion with the student about their initial proposal form, and then discussion surrounding the maintenance of a 'dissertation log', which is signed by the supervisor and the student at each meeting as a record of progress and action.

This log and the research proposal must also be submitted with the dissertation. Together, these provide evidence upon which summative assessment is made of the management of the research strategy and skill and practice development. Other learning outcomes are assessed summarively through the dissertation document itself and the 'reflective chapter'.
