# **COURSE PREREQUISITE**

JAZZ 496 with grade of C+ or higher.

## **COURSE FORMAT**

Two lecture hours and four instructor-led lab hours per week for 15 weeks.

## **CALENDAR DESCRIPTION**

This course focuses on small ensemble performance. Students will work independently and in coached settings to create full-length concerts of original compositions and arrangements presented at a professional level. In consultation with the instructor, students will conceive and execute a significant final project featuring original compositions. This project will be documented with high-quality audio and video recordings.

#### **COURSE NOTE**

JAZZ 497 is an approved Capstone course for Cap Core requirements.

## **COURSE STUDENT LEARNING OUTCOMES**

# On successful completion of this course, students will be able to do the following:

- rehearse and perform a large variety of jazz repertoire with small ensembles;
- apply techniques for spontaneously arranging and structuring performances of jazz standards and original compositions;
- arrange and compose original compositions for small ensembles;
- demonstrate artistic vision and imagination in the creation of new works;
- organize, perform, and record an original project of substance in collaboration with other musicians;
- program and perform concerts and recitals of a professional level with substantial length, creative scope, and technical complexity;
- interpret works from the standard jazz repertoire and explore possibilities for an individual and creative approach to this tradition;
- apply improvisational skills learned in Jazz 382 and 382;

• work effectively with a team of peers by communicating, discussing, and negotiating creative ideas with their peers;

- show through performance and rehearsals evidence of the personal study habits and work ethic critical for professional success
- spontaneously create melodic lines and rhythmic and harmonic accompaniments in various styles with attention to the conventions of those styles;
- demonstrate through performance a thorough understanding of melodic and rhythmic relationships within a variety of harmonic and formal structures.

## Students who complete this Capstone course will be able to do the following:

- Identify a topic of inquiry or practice
- Gather and organize relevant research materials
- Evaluate, synthesize, and apply research findings
- Share findings or results in a means appropriate to a field of study

#### **COURSE CONTENT**

Students work as teams and in close consultation with instructor to plan, program, arrange, rehearse, perform, and record repertoire for recitals and the capstone project. Please note that some recitals may be held at off-campus venues as and when such opportunities arise.

#### **EVALUATION PROFILE**

### Recitals

Each ensemble will perform two recitals of 45 minutes duration. Students are required to demonstrate improvisation and ensemble interaction skills appropriate to this level of study and must make a clear, creative, and assertive contribution to performances. Recitals may be arranged at Capilano University or at off-campus venues. If the performances are outside the regular class timetable or off-campus, an audio recording must be made and submitted to the instructor for the purpose of evaluation.

### **Preparation for Recitals**

Students are expected to come to class ready to rehearse. This means that they have already gathered and organized relevant research materials, have learned notated parts, are ready to improvise solos and accompaniments, and have developed and prepared arrangement ideas to share with the ensemble. With this in mind, the instructor will regularly evaluate the individual preparation, attitude, and work ethic of each student.

## **Final Capstone Project**

The student is expected to conceive and execute a unique original project of substantial creative scope and significance demonstrating their artistic vision and capacity to integrate skills and abilities learned in the Jazz Studies program. Both group and individual projects are possible, though collaborative work on a group project will be encouraged. The project will be developed in close

consultation with the instructor. Projects should include original compositions or creative arrangements of existing repertoire and present technical and conceptual challenges appropriate to this level of study. The project will be documented with audio and video recordings. Students will work with the department's Technical Director to make arrangements for these recordings.

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Fraud**: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
