4 hours of instruction over 7 weeks

CALENDAR DESCRIPTION

Students will learn the key concepts of organizing touring entertainment, focusing on the administrative and management responsibilities such as booking, budgeting, financing, routing, staffing, and decision making. Students will learn to generate contracts, riders, and stage plots as well as negotiate fees and working conditions for touring artists. Working with both music concert tours as well as performing arts tours, such as theatrical tours and ballet companies, students will be able to determine suitable venues to suit the needs of the production.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Explain the key elements within the Canadian and international performing arts touring ecology including the nature of the market, timelines and materials needed to enter the market
- Plan and book a tour for a performing artist or company
- Negotiate appropriate fees and working conditions for touring artists
- Generate and interpret a contract and rider using language used in the contemporary entertainment industry
- Apply for funding from appropriate bodies to support a tour
- Assist in the management and assemble a team to support a tour by a performing artist or company
- Communicate effectively with members of a production team
- Interpret and create stage plots and technical riders
- Determine backline, staging, lighting, and rigging needs for an artist and match to an appropriate venue
