COURSE FORMAT:

Three hours of class time, plus an additional hour delivered through on-line or other activities (field trip, etc.) for a 15 week semester, which includes two weeks for final exams.

COURSE PREREQUISITES:

None.

COURSE DESCRIPTION:

This course is an in-depth look at art and the environment, in particular the changing perceptions of nature in art through time and, more currently, art activism and art collaboration in relation to climate change, ecological crisis, and the anthropocene. This course looks at how artists have examined the human relationship to the landscape and the planet, from earth art, to repurposing trash, to developing visual strategies to accompany protests and enhance advocacy. How have various community groups collaborated in common causes? How have First Nations artists used art to respond to environmental dangers? We will examine a number of case studies to understand the intersections of art and the environment and our examples will range from paintings to sculptures, earthworks to photography, and mixed-media installation.

The material in the course is presented as both a series of power point lectures (with visual examples) and class discussions of the readings. Be prepared to contribute to and/or lead group discussions of the weekly readings.

COURSE LEARNING OUTCOMES:

Upon successful completion of this course, students will be able to:

- Articulate a broad understanding of artistic interventions into questions of the landscape, the human connection to nature, to environmental activism, to species and animal survival;
- Express in speech and writing the ways in which art contributes to scientific and cultural investigations;
- Utilize the specialized vocabulary learned to describe and interpret art approaches,
- Apply this understanding to written work, including an exam and a final project.
