COURSE FORMAT:

Two hours of class time per week for a fifteen-week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION:

This course is designed to allow further exploration of voice training for the stage and screen. Students will strengthen the range of their voices through training and performance. Skills are evaluated in tests, presentation and performance projects.

COURSE NOTE:

For Acting for Stage and Screen program students only.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- improve on their physical alignment;
- increase their breath capacity and articulation
- increase their vocal power and projection;
- apply their skills in workshop and performance settings.

COURSE CONTENT:

This is a fundamental voice training course for the Acting for Stage and Screen students. Students will experience studio training and projects which are designed to improve alignment, breath capacity, vocal power and articulation with a focus on the application of Alexander Technique principles. Skills are evaluated through exercises, presentations and performance projects.

The content and week-by-week breakdown of the course will vary by term and instructor. The following is a sample:

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
