COURSE FORMAT

Two instructional hours per week for a 15-week semester, which includes 2 weeks for final exams.

CALENDAR DESCRIPTION

This course is designed to expose intermediate actors to the specific demands of the industry and prepare them for marketing their skills in the competitive world of theatre, film and television acting.

REQUIRED TEXTS AND/OR RESOURCES

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Differentiate audition processes for TV commercials, stage and film;
- Apply and analyze the process of interpreting film script "sides" for scene work;
- Employ techniques in making choices that bring life to scene work;
- Acquire skills in executing choices prior to a rehearsal process.

ASSIGNMENTS

The assignment structure for this course is determined by the instructor in accordance with the learning outcomes outlined above. Please refer to the course syllabus and eLearn site for a more detailed breakdown.

Solo In-Class Assignments

Individual assignments are meant to familiarize the actor with the details of on-camera work. These may include slating, learning details of off-camera eye lines, and auditioning with a non-actor, such as a reader.

Group In-Class Assignments

Group In-Class Assignments may include workshops for scenes, or performing a scene on camera with a partner or small group.

Written Assignments

Written assignments may include approach papers, where students articulate their goals and ideas in approaching a particular scene, or reflections, where students have a chance to evaluate themselves, the work they did, and goals for future work.

Professional Practices

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing

aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
