- 1. Describe how the First Peoples Principles of Learning can be considered together with the Early Learning Framework Principles as it relates to curriculum formation

- 3. Develop responsive and collective experiences with materials that disrupt instrumental practices
- 4. Create notational documentation of curriculum engagements that demonstrates attention to the social construction of understandings

#### COURSE CONTENT

- An introduction to reconceptualizing perspectives in early childhood curriculum.
- An introduction to the BC Early Learning Framework (BC ELF) and First Peoples Principles of Learning
- The principles and pedagogical orientations of the BC early learning framework as it relates to curriculum formation
  - Images of learning: social construction, inquiry, disrupting developmental perspectives and learning as individual
  - The image of the child and the image of the educator
  - Orientations to curriculum-making curriculum as made/produced/lived
  - Pedagogy of listening
- Pedagogical attunements, orientations, and sensitivities: paying close attention, noticing details of the processes
- Collective improvisations
  - Improvising with ideas and materials
  - Living with stories, songs and movement
- Explorations with notational pedagogical documentation:
  - Paying attention to relationalities and what is being produced
  - Keeping detailed and descriptive notations using images, sound, and text
  - Short writing exercises that narrate nuances of the processes
  - Making collective decisions

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
