## COURSE FORMAT

Three hours offered by lecture, online or mixed mode plus additional fourth hour activities each week for a 15-week semester, which includes two weeks for final exams. Fourth hour activities will be delivered in a variety of ways. Instructions for fourth hour activities will be posted on the course elearn site.

## COURSE PREREQUISITES/CO-REQUISITES

45 credits of 100-level or higher coursework; and ENGL 100 as a pre- or co-requisite.

## CALENDAR DESCRIPTION

In this advanced curriculum course, students will engage with pedagogical practices related to curriculum that reflects the BC Early Learning Framework (BC ELF) and current directions and practices in the reconceptualizing early childhood movement. The emphasis will be on putting theory to work in curriculum while thinking with social constructionism, new materialism and post humanism as these are the theories that ground the BC ELF.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
