### **COURSE FORMAT**

Three hours of class time, plus an additional hour delivered through online or other activities for a 15-week semester, which includes two weeks for final exams.

### **COURSE PREREQUISITES**

45 credits of 100-level or higher coursework including 6 credits of 100- or 200-level ENGL

### **CALENDAR DESCRIPTION**

This course studies selected works of Canadian literature in any genre(s) that are important for their artistic, cultural, and/or historical content and contexts. Depending on the term, iterations of the course may focus on specific approaches, critical issues, and/or literary periods. Sample course titles: Canadian Ecocritical Literature, Postcolonial and Decolonial Literatures in Canada, Canadian Literary Urban Fiction, the Canadian Graphic Novel.

### **COURSE NOTE**

ENGL 305 is an approved Culture and Creative Expression course for Cap Core requirements. For the focus of the course each term, see the "Courses" page on the English Department website.

### **REQUIRED TEXTS AND/OR RESOURCES**

A selection of fiction, poetry, drama, and/or other primary works, along with critical and scholarly readings. The course may make use of a published anthology or coursepack. Specific texts will vary depending on the instructor and term.

### **COURSE STUDENT LEARNING OUTCOMES**

**On successful completion of this course, students will be able to do the following:**

1. Critically evaluate a selection of Canadian literature and its significance within given historical and cultural contexts, including settler-colonialism.
2. Identify and explain how works of Canadian literature are situated within broader national or transnational literary cultures, traditions, schools, movements, or canons with a critical awareness of and sensitivity to racism in Canada in the past and present.
3. Read with attention and make original use of detailed observation, synthetic thinking and informed interpretation in written and oral work.
4. Analyse settler-colonial, racial, and heteropatriarchal power structures as both sustained and critiqued by Canadian literature and criticism.
5. Recognize the limited, exclusionary, and colonial nature of the literary canon. Attend to the important work that has been done to critique, expand, and diversify the canon.
6. Compose essays and other written work that is alert to the complexity and nuance of literary texts, that considers the historical forces bearing their production, and that weighs their relevance or utility in thinking about important issues in literary studies, including colonialism in its past and present forms.
7. Work cooperatively and respectfully with other students to expand individual understandings of course readings and to foster new directions in discussion, research, and writing.
8. Undertake rigorous research that integrates various methodologies and perspectives, including self-reflexivity about one's positionality, lived experiences, and communal/social responsibilities.

**Students who complete this Culture and Creative Expression course will be able to do the following:**

1. Engage in creative processes including conception, investigation, execution, and ongoing critical analysis.
2. Identify, analyze, and critique the elements of a form of expression using its specific vocabulary.
3. Explain or demonstrate the connection between various events, ideas, traditions, and belief systems and the modes in which they are artistically or culturally expressed.
4. Interpret diverse forms of creative expression from different perspectives (e.g. artistic, historical, Indigenous, literary, scientific, philosophical).

**COURSE CONTENT**

This course may include quizzes (e.g. pop quiz, reading quiz). The format of the quizzes will be determined by the instructor and may include a combination of short answer and essay questions.

**Presentation**

This course may include a presentation component, which may be an individual or group assignment (e.g. in-class debate, academic poster, research presentation). Detailed instructions will be provided in class and on eLearn.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
