#### **COURSE FORMAT**

Four lecture hours per week for a 15-week semester, which includes two weeks for final exams.

#### **CALENDAR DESCRIPTION:**

This course introduces musical concepts of organization, such as rhythm, pitch, structure, form and style, and applies knowledge of these concepts in analytical exercises. These concepts of musical structure are used to trace the development of art music from ancient times to the end of the Classic Period. The course then examines representative music of the Medieval period with respect to style and form, examining the historical framework in which this music was composed, and providing the student with the necessary tools to express this knowledge.

**DESCRIPTION OF ASSIGNMENTS:**

- Bibliography Assignment** The student will choose a composer from the Renaissance or Baroque periods in music and produce an annotated bibliography relevant to that composer's life and works. The bibliography will be comprised of sources ranging from textbooks, encyclopaedias, dictionaries, monographs and journals, online sources and discographies. Each entry will show a knowledge of proper bibliographic style with a general commentary on its content.
- Concert Attendance** The Concert Attendance grade is based on the student's attendance at the Cap Classics and Re-Sounding CapU concerts which take place numerous times during the semester during the concert block. If unable to attend, students are allowed to attend an outside concert of Art Music and submit a brief concert review, along with a program and/or ticket.
- Listening Journal** Students will record thoughts and impressions of listening examples and class discussions. The journal can be submitted in written form, or another form approved by instructor.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
