**COURSE FORMAT**: Two hours of class time for 15 weeks, which includes a 2-week examperiod.

**COURSE PREREQUISITE:** ACTR 201

**CALENDAR DESCRIPTION**: Students will experience studio training and projects which are designed to improve alignment, breath capacity, vocal power, articulation and the exploration of various dialects. Embodiment, presence, specificity and authenticity are considered to be key terms in the evaluation of this work.

**COURSE NOTE:** For Musical Theatre program students only.

**REQUIRED TEXTS AND/OR RESOURCES:** Required texts and/or readings will vary by the instructor. They may include books on methodologies or samples of scripts.

#### **COURSE STUDENT LEARNING OUTCOMES**

On successful completion of this course, students will be able to do the following:

- Determine advanced physical and vocal techniques to increase their vocal power, articulation, and projection;
- Apply vocal training to support individual career goals;
- Combine the principles of advanced physical and vocal training for both stage and screen;
- Examine various dialects used in performance;
- Advance skills in workshop and performance settings for stage and screen in an embodied and authentic manner.

### **COURSE CONTENT**

This is an intermediate voice training course required for work on the stage and in front of the camera. Students will experience studio training and projects which are designed to improve alignment, breath capacity, vocal power, articulation and the exploration of various dialects. Students will be evaluated on their willingness to adopt the training methods and successful synthesis of the techniques with performance. Embodiment, presence, specificity and authenticity are considered to be key terms in the evaluation of this work. Skills are evaluated through exercises, presentations and performance projects. The content and week-by-week breakdown of the course will vary by term and instructor. The following is a sample:

**Academic Dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating**: Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud**: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

Taking unauthorized possession of the work of another student (for example, intercepting
