COURSE FORMAT:

Three hours of class time, plus an additional hour delivered through on-line or other activities, for 15 weeks, which includes two weeks for final exams.

COURSE PREREQUISITES:

45 credits of 100-level or higher coursework including PSYC 100.

COURSE DESCRIPTION:

This course will address research and theories in the topic of feelings and emotions. Students will learn about the experience, expression, physiological and social aspects of specific emotions, including stress reactions, attachment bonds, and the development of empathy. The theories will be applied to the problems of human social cognition and the effect emotional reactions can have on our thinking and relationships.

- Develop a working knowledge of psychology of feelings and emotions

- Demonstrate information literacy with literature on the psychology of feeling and emotions
- Incorporate sociocultural factors in scientific inquiry on feelings and emotions
- Describe how psychology can promote civic, social, and global outcomes that benefit others
- Apply ethical standards to evaluate psychological science and practice
- Demonstrate effective writing on topics in the content domain
- Exhibit self-efficacy and self-regulation
- Apply ethical standards to evaluate psychological science and practice

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting
 and removing such work from a photocopier or printer, or collecting the graded work of
 another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
- Impersonating or allowing the impersonation of an individual;
- Modifying a graded assessment then submitting it for re-grading; or,
- Assisting or attempting to assist another person to commit any breach of academic integrity.
