As a result of interest from the industry since the inception of the program and the many enquiries about part time participation, four new costuming courses were developed by breaking apart an existing credit course into four distinct courses of 1.5 credits each to facilitate part time students.

During the review of the new course however, members questioned whether sufficient consultation had been undertaken with other departments and if more detail should be included in the course content. As a result of the discussion, the course was not approved until further consultations and clarifications were undertaken.

Four new non-credit Continuing Education courses were presented for approval. Discussion arose regarding one of the courses, GNLG 912 Tools for Living Joyously, and some members expressed concern on the suitability of offering this course at the University. As a result of the discussion, this course was not approved.

#### **FOLLOW-UP ITEMS**

Quantitative/Analytical Courses List

Presented by: Wendy Lynn and Anna Lee Boulton

Wendy presented an update on the progress of the ad hoc committee developing a process for evaluating requests for courses to be listed on the Quantitative/Analytical Courses list. The committee developed and presented wording and instructions to be included in the Course Approval Form, as well as a Quantitative/Analytical Course Certification Request to be completed when quantitative/analytical status was requested. Discussion arose on instances when courses could have quantitative or analytical characteristics and whether these courses should be classified, and members agreed that this area would be vague and require review. Anna Lee presented a background on the previous and current processes used at SFU in granting quantitative/analytical status to courses. In this regard, there was discussion on whether, at Capilano, there was a need to recruit specialists to a committee, or if it was more beneficial to define clear criteria which a group such as SCC, can apply with consistency. The committee was thanked for their work to date, and that they continue to work on criteria.

Jackie followed up on the issue of grading profiles. Members were asked if discussions had been carried out at their faculties on moving towards more consistent grading profiles to be used at either a faculty or institutional level. Members reported regarding their discussions within their faculties. Generally, members agreed that it was important to maintain consistency of grading profiles, at least at the faculty level and preferably at the institution level. A suggestion was made that this issue be taken as a recommendation to Senate to put together a committee to look at grading profiles across the campus.

Peter Holden moved and Rorri McBlane seconded that:

**10/70** Recommendation that Senate strike a committee to consider a single grading profile for the institution.

CARRIED 2 abstentions (Wendy Lynn Rita Isola) Members of SCC requested that a copy of the policy S2009-03 Requirements for Credentials be attached to the October agenda.
