### **COURSE FORMAT**

One and half hours of class time, plus one- to two-week immersive trip to Land School location for a 15-week semester.

# **COURSE PREREQUISITES**

45 credits of 100-level or higher coursework including 6 credits of 100 or 200-level ENGL

## **CALENDAR DESCRIPTION**

This course offers experiential study of the literature, history, and culture of a Land School location, with a focus on introducing students to Indigenous ways of knowing. The Land School may be organized around critical approach, historical period, decolonizing practices, or geographical and cultural area. The course has three parts: classroom time, a one- to two-week immersive Land School experience that encourages students to consider place as a form of learning, and opportunities for reflection.

## **REQUIRED TEXTS AND/OR RESOURCES**

A selection of fiction, poetry or drama, and/or other primary works, along with critical and scholarly readings. This course may make use on a published anthology or coursepack. Specific texts will vary depending on instructor and term.

# **COURSE STUDENT LEARNING OUTCOMES**

On successful completion of this course, students will be able to do the following:

1. Draw connections between the experiential learning of the Land School and areas of academic interest within Creative Writing and/or English Literature.

- 2. Consider and articulate the value of the knowledge and skills acquired in their program and the Land School beyond an academic setting.
- 3. Conduct advanced Land School research into the specific events, ideas, and antagonisms that contribute to the emergence of cultural practices, networks, and traditions.
- 4. Reflect on how specific social, political, and legal concepts inform and are in turn challenged by literary and other cultural formations.
- 5. Compose essays and oral responses with a degree of historical awareness, self-reflection, analytical rigour, and imagination.
- 6. Draft and revise written work that conforms to accepted practices for presenting scholarship while also striving to be insightful, original, and creative.

Students who complete this Culture and Creative Expression course will be able to do the following:

- 1. Engage in creative processes including conception, investigation, execution, and ongoing critical analysis.
- 2. Identify, analyze, and critique the elements of a form of expression using its specific vocabulary.
- 3. Explain or demonstrate the connection between various events, ideas, traditions, and belief systems and the modes in which they are artistically or culturally expressed.
- 4. Interpret diverse forms of creative expression from different perspectives (e.g. artistic, historical, Indigenous, literary, scientific, philosophical).

Students who complete this Self and Society course will be able to do the following:

- 1. Identify potential root causes of local/global problems and how they affect local/global cultures, economies, politics, and policies.
- 2. Assess and evaluate individual and collective responsibilities within a diverse and interconnected global society.
- 3. Analyze the impact of colonialism and racism on Indigenous peoples.
- 4. Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change.
- 5. Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures.

Students who complete this Experiential course will be able to do the following:

- Critically reflect on their progress and development in the context of the course and assess the utility of the acquired knowledge, skills, and values in the learner's personal, academic, or professional trajectory.
- 2. Apply the skills and knowledge of a given discipline or professional context, including working collaboratively in both leadership and team roles.

## **COURSE CONTENT**

Fraud: Creation or use of falsified documents.

**Misuse or misrepresentation of sources**: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism**: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism**: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct**: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting
  and removing such work from a photocopier or printer, or collecting the graded work of
  another student from a stack of papers);
