CapU's priority is the health and safety of both students and employees. The following protocol is designed as a general best practice that can be used as a student COVID-19 illness process in conjunction with the University's response to COVID-19 and in accordance with the <u>COVID-19 Go-Forward Guidelines for B.C.'s Post-Secondary Sector</u>.

Primary guidelines for students when they become sick should include, but are not limited to:

- Do not attend activities if you are sick or feel cold or flu-like (COVID-19) symptoms such as: new or worsening cough, chills, shortness of breath, fever, new muscle aches, headache and/or sore throat.
- **2.** All students should be aware of symptoms of illness and not come to the University if sick or symptomatic.
- 3. If a student has symptoms, they should complete the BC Centre for Disease Control (BCCDC) <u>COVID-19 Self-Assessment</u> and follow guidance from BCCDC, which may include booking a COVID-19 test.
- **4.** Instructors and lab supervisors are required by the *COVID-19 Go-Forward Guidelines for B.C.'s Post-Secondary Sector* document to maintain a record of attendance, in the event of contact tracing. Contact tracing would be the responsibility of BCCDC, if the student tests positive for COVID-19.



Procedure if a student becomes sick while at university:

- 1. If a student becomes sick, they should leave the classroom, lab or workspace immediately if they are well enough (see transportation options below).
 - a. The student should wear a mask while leaving the premises and/or while waiting for transportation. Campus Security/First Aid (604 984 1673) can be contacted to provide a mask to a sick student.
 - b. If the student needs to wait for transportation, they may stay indoors while maintaining a two-metre physical distance from others.
 - c. If weather is nice and student is well enough, they can stay outside while waiting for transport.
- 2. Instruct student to perform hand hygiene and avoid contact with others or the environment.
- **3.** Identify the areas and surfaces that the student was in contact with or close to (within two metres) for cleaning:
 - a. Refer to the Safe Work Practices for both classrooms and offices
 - b. Contact cleaningrequest@capilanou.ca to request cleaning
 - c. Contact safety@capilanou.ca to notify of the exposure
- **4.** Once at home, the student should complete the <u>COVID-19 Self-Assessment</u> on the BC Centre for Disease Control website or call 8-1-1 and follow the directions.
- **5.** Students should inform their supervisor, instructor or, if in residence, their residence advisor of their absence.
- **6.** Students may also reach out to support resources such as Student Success, Registrar's Office, Centre for International Experience, Indigenous Student Services and residence advisors.
- 7. Student should attempt to identify a list of people with whom they were in close contact (within two meter without physical barrier or without PPE) should a positive COVID-19 test indicate a need for contact tracing.
- **8.** Students will remain off campus until cleared to return in accordance with self-assessment or testing results (based on BC Centre for Disease Control isolation criteria).

Procedure if a student becomes sick while on practicum:

- 1. If a student becomes sick, they should follow the instructions of their practicum site.
- **2.** Once at home, the student should complete the <u>COVID-19 Self-Assessment</u> on the BC Centre for Disease Control website and follow the directions.



- **3.** Students should inform their supervisor, instructor or, if in residence, their residence advisor of their absence.
- **4.** If it is determined that the illness was contracted as a result of the practicum, the student should fill-out the appropriate WorkSafeBC Claim.

Recommended transportation options (in order):

- 1. Student drives themselves home.
- **2.** Pick up by family or friend:
 - a. Remind student to keep distance.
 - b. Masks can be obtained through Campus Security/First Aid (604 984 1673) if department does not have a mask to give to student.
 - c. Have a peer come to pick up mask.
- **3.** Pick up by taxi:
 - a. Provide student with mask and instructions to perform hand hygiene before entering the vehicle.
 - b. Avoid touching inside the vehicle.
 - c. Keep mask on for the duration of ride.
 - d. Note: you will have to check with the taxi company if they will be able to transport and take precautions (e.g., clean inside of the vehicle, etc.).
- **4.** Public transit is asking people not to ride the bus, SeaBus or SkyTrain if they have COVID-19 symptoms.
- **5.** Call 9-1-1 for individuals requiring emergency medical assistance.

Continue to practice good hand-washing techniques and hygiene practices.

- Wash your hands often with soap and water for at least 20 seconds. If soap and water is not available, use an alcohol-based hand rub to clean your hands.
- Avoid touching your eyes, nose or mouth with unwashed hands.
- Cough or sneeze into your elbow or sleeve.
- Dispose of tissues appropriately.
- Avoid contact with sick people and stay at home or in your residence room if you are experiencing flu-like symptoms.
- Frequently clean high-touch surfaces such as electronics, computer keyboards and phones.
- Practice physical distancing—maintaining at least two-metres distance between yourself and others.
