7.1 Academic Planning and Program Review Committee

The Committee met on February 8 and approved the 2019/20 program review cycle as complete for the following programs:

- Bachelor of Legal Studies (Paralegal);
- Diploma in Paralegal;
- Certificate in Paralegal;
- Certificate in Legal Administrative Assistant; and
- Citation in Criminal Law Practice and Procedures.

7.1.1 Stage 1 - Bachelor of Arts with a Major in Governance, Policy and Justice

The Bachelor of Arts with a Major in Governance, Policy and Justice (GPJ) is a multidisciplinary, modular, 120-credit degree that aims to provide a broad-based, applied, and interdisciplinary approach to the interconnected study of Philosophy, Politics, and Economics (PPE) by exploring subjects of common concern to each. The Major in GPJ builds on existing resources in the philosophy, politics and economic departments within the Faculty of Arts and Sciences. Most required lower-level courses are already on offer; up to six new courses at the upper level will be developed to deliver the proposed curriculum.

On discussion a question was raised on whether the Capilano public administration local government program had been consulted around the development of the proposal. Information was provided that, as a stage 1 proposal primarily focusses on the benefit of the program, review of the course based collaboration piece will be addressed if and when the proposal is recommended by the Ministry.
