Senate was provided with a brief summary of the results of the Senate selfevaluation survey. The survey opened April 1 and closed May 13, 2016 and

Some issues noted were that there was a lack of clarity on Senators' role with respect to academic governance and that more information be provided on the role of subcommittees and background on how decisions are made.

Some suggestions already being acted on include increasing the joint meetings with the Board of Governors to two per year, and developing *University Act* workshops to ensure good understanding of the *University Act*.

On discussion, a suggestion was presented to devote either a portion or the entire October Senate meeting for a Senate orientation. In this regard, an ad hoc committee was formed to develop an agenda for the orientation.
