6.1 Senate Orientation Date

7.1 Approvals in Principle

Minor in Liberal Studies

Senate reviewed the Minor in Liberal Studies Approval in Principle. The proposed new program responds to extensive studies and calls from employers for students with highly developed research, writing and critical thinking skills. The Minor in Liberal Studies invites students from Capilano's baccalaureate degrees (excluding the Bachelor of Arts in Liberal Studies) to complete an integrated liberal arts minor building on the courses currently

16/82 Senate approve the Minor in Liberal Studies Approval in Principle, and recommend to move forward to final approval.

Certificate in Applied Science: Engineering

Senate reviewed the Certificate in Applied Science: Engineering Approval in Principle. The proposed new credential will identify and recognize students who complete this challenging program and bestow recognition for their work and success. As well, the credential will smooth establishment of educational partnerships with other post-secondary institutions that offer full four-year APEGBC accredited degrees in Engineering by verifying that a student has completed the program in its entirety.

7.2 Signed Letter on Sexual Misconduct Statement

As background, a Presidential Advisory Committee made up of representatives from across the university community, was established to develop policy and procedures on sexual violence and misconduct at Capilano.

As an interim step and prior to arriving at policy, Senate was presented with a University declaration, with full support of the CFA, CSU, MoveUp and Administration, on its commitment to address issues of sexual violence and misconduct.

The Presidential Advisory Committee continues to work on developing policy and procedures, as well as establishing required protocol and training. The

8. Committee Reports

8.1 Curriculum Committee

Presented by: Deb Jamison

The resolutions brought forward from the November 18th Senate Curriculum Committee meeting were presented to Senate for approval.

Deb Jamison moved and Halia Valladares seconded: 16/84 SCC resolutions 16/74 and 16/75 be endorsed by Senate. CARRIED

On review of SCC motion 16/76, Senate was requested to approve discontinuing the requirement for Continuing Studies & Executive Education to submit non-credit courses and programs through the SCC and Senate approval process. It was noted that the University Act does indicate there is a division between credit and non-credit and that it is the responsibility of the Board to develop a policy for reporting of non-credit courses.

Deb Jamison moved and Sharka Stuyt seconded:

16/85 SCC resolution 16/76 that Senate no longer requires Continuing Studies & Executive Education to submit non-credit courses and programs through the SCC and Senate approval process, but still require full consultation as per current practice and submit a report on a monthly basis, as required, for information to both SCC and Senate be endorsed by Senate.

CARRIED

SCC resolution 16/77 was presented as information only.

Deb Jamison moved and Caroline Depatie seconded: **16/86** SCC resolution 16/78 be endorsed by Senate.

8.4 Instructional Technologies Advisory Committee

Presented by: Don Bentley

A forum was recently held to solicit feedback on technology issues at the University; however, the forum was not well attended as a result of the scheduled meeting block. A further opportunity will be provided in the Spring to again solicit feedback from the broader campus, as well as to address faculty technology needs.

The Committee is also discussing the possibility of web conferencing within the University and with the regional campuses, and looking at ways in order to connect the communities.

8.5 Budget Advisory Committee

The Committee met on November 29th, and Bacel Younan was elected as Chair for the 2016/2017 year. At the meeting, an overview of the government mandate letter was provided, an operating grant of approximately \$36.9M is expected and a domestic enrolment target of 5,449 FTEs.

The Committee indicated support for an early communication plan to ensure clarity around budget decisions.

A further committee meeting is scheduled for January 24th, at which time the committee will review draft budget documents.

Halia Valladares will serve as an administrator on the Committee; however, there still remains one vacant faculty position.
