# 4. Residency Requirement for the Bachelor of Arts Degree (motion 21/01)

Presented by: Miriam Elfert

As background, distance students who could not attend classes on campus to meet the requirement of 9 credits of upper-level courses were no longer able to meet the residency requirements at Capilano and were not eligible to graduate from the BA-ABA program. As such, at the January 24, 2020 SCC meeting, the SCC members approved decreasing the residency requirement from 50% to 25% for the BA-ABA as an interim solution, with the longer term

and broader goal of developing more upper-level online courses that could be taken by BA-ABA students (as well as other students) to meet the elective requirements.

Because of the pandemic and the shift to online learning, there are now more online options for upper level electives at Capilano for those students to remain at Capilano instead of taking courses with competitor institutions to fulfil their course requirements.

However, as there is still uncertainty as to whether the online options will continue, it was suggested that the exception continue, and that a further update be provided in another year.

22/11 It be recommended to Senate for approval that the residency requirement for the Bachelor of Arts Degree – Applied Behaviour Analysis (Autism) continue to be reduced from 50% to 25% for distance students on a further interim basis, to be reviewed again in one year.

#### 13. BUSINESS ITEMS

(a) Unassigned Credits Memo

Presented by: Kyle Vuorinen

As background, students transferring credits from another post-secondary receive credits in two formats on their transcripts: direct course-to-course transfer or unassigned transfer credits are provided when Capilano University does not have a direct course equivalent. When students receive unassigned transfer credits for courses completed elsewhere, it is challenging to determine appropriate Cap Core categories for "unassigned" courses.

Rather than requiring transfer students to take additional courses thereby increasing degree costs and hindering timely credential completion, the Registrar's Office proposed that the University adopt a learned-centered approach to maximizing the opportunities for transfer students to use unassigned transfer credits towards their Cap Core requirements.

Based on a review of the most commonly assigned Cap Core categories by subject code, the Registrar's Office proposed the adoption of a Cap Core Course Registry establishing how unassigned transfer credit by subject code can be used towards Cap Core requirements.
