4. ABE

Adult Basic Education – General Upgrading Admission Requirement

In order to provide clarity on the admission process and reduce barriers to admission requirements and to reflect admission procedures currently in use, SCC was requested to approve the following revisions to the admission policy language on the Capilano ABE webpage:

- **Current Admission Requirements:**

Basic requirements

- It is recommended that applicants have the equivalent of English 10 to facilitate the successful completion of the writing and math skills assessment.
- Writing and math skills assessment and an interview with the department is required before students can register in ABE courses.

- **Proposed Admission Requirements:**

Basic requirements

- Basic English and computer skills
- Written English language assessment

Program-specific requirements

- Interview
- Written paragraph outlining educational goals

Additional information

- Applicants whose first language is not English may be required to complete English for Academic Purposes (EAP) courses prior to admission to the ABE program.
- Assessments in each subject area (English assessment and written paragraph are mandatory) are done online and will allow students to demonstrate their current skill level and assist with placement (can be used to skip entry level courses)
- Interview with department faculty will determine the appropriate course and delivery methods to support individual educational objectives

On discussion, members expressed concern that the proposed admission requirements, as currently worded, may unintentionally create higher perceived barriers for prospective students. It was noted that the reference to “basic English and computer skills” was potentially vague, and members suggested that providing measurable or example criteria that the ABE program considers applicable could help ensure applicants are not discouraged from applying due to uncertainty about expectations.

Members also discussed the inclusion of the term “interview,” observing that this language may feel intimidating for applicants and could be interpreted as a screening or gatekeeping mechanism rather than a supportive step in the process. Some members suggested alternative language—examples included, “mandatory advising session”, “conversational interview”, “guidance meeting,” “intake conversation”—to more accurately reflect the intention of providing guidance and support.

Additionally, some members had questions regarding the written paragraph outlining educational goals. Members questioned whether this was an effective or equitable measure of student’s writing ability. It was noted that if the purpose is primarily to assess writing skills, applicants could perceive this requirement as a barrier, especially at a time when the institution is trying to reduce access barriers. There was further discussion about the importance of ensuring that students receive the appropriate level of support early so that they can succeed in their studies.

Committee members suggested that the messaging around these elements could be “softened” to communicate support, and that the program’s initial point of contact (e.g. the DDA) could help facilitate conversations and ensure that the applicants feel supported throughout the process.

The presenter indicated that the feedback and suggestions will be taken back to the department for consideration. It was also noted that work is currently underway to review the English Proficiency Standard, which may address some of the concerns presented in the discussion.

It was suggested that moving forward, Indigenous consultation be noted as this is an important aspect and supports the discussions particularly when the committee is reviewing *Self and Society* Cap Core designations.
