Bachelor of Science – General Program Profile

The Bachelor of Science degree program has been offered since Spring 2022. The program profile is being revised to clarify and simplify requirements that have caused confusion for students. Also, the upper-level course requirements are being updated to ensure that the course offerings are current, and that students are taking a variety of courses, both within the concentration and as science electives that are appropriate for BSc students. SCC was requested to approve the following revisions to the program profile:

- Update to the lower-level Statistics requirement to align with BSc framework.
- Update to lower-level Biology requirement to remove courses that are no longer offered.
- A change in Upper-Level Science requirement to ensure that students take courses that are appropriate for science students.

- Listing STAT 310 as an explicit program requirement for all BSc students.
- Updates to the concentration courses to remove courses that are unlikely to be offered and require students to choose concentration courses from "at least two different disciplines".

On discussion, a concern was raised regarding the BADM 210 course that was removed as it was the only interdisciplinary course outside of Arts and Sciences and the impact of removing the course. The presenter indicated that students were seeking the course; however, the course is a program restricted course for BADM students. The intention was that if students transfer from a business program to the Bachelor of Science and have already taken the course or equivalent, they will get credit for the course. In this regard, it was suggested that the presenter consult further on whether it should continue to be offered.
