As well, more information on the service provider and on their integrity was requested.

This course was last run in 1999; however, the department requested that this course be re-offered because they are expecting some of the new students to need this level. There was a discussion regarding the naming of the ESLF English Language courses and SCC agreed that this course could be approved and run with the title as is.
