The pre-requisites of EDUC 371 Family, School and Community are being amended to "EDUC 176 or permission from the ECCE department" to enable students to complete the required courses in sequence. The pre-requisites of EDUC 475 Graduating Seminar are being revised in order to attach the specific courses which allow students to enter the practicum at this level.

The Diploma in the Tourism Management Co-op program profile is being revised to indicate a change in course sequence in which English 100 will be offered in the third term instead of the fourth term, and Tour 208 offered in the fourth term instead of the third term.

The Diploma in the Tourism Management for International Students program profile is being revised to indicate that the new Entrepreneurship in Tourism course (currently being developed) will not be a required course for the fourth term but instead added as an elective, and Tour 200 Revenue Management for Tourism added as a required course for the fourth term instead of as an elective.

**09/80** The revisions to the Diploma in the Tourism Management for International Students Program Profile be recommended for approval to the Senate.

Due to a previous typographical error listing Tour 154 on the program profile in both second and fourth terms, the Diploma in the Destination Resort Management Co-op program profile is being revised listing Tour 154 only in the second term.

**09/81** The revisions to the Diploma in the Destination Resort Management Co-op Program Profile be recommended for approval to the Senate.

As there is an indication that a letter of intent will better demonstrate a potential student's determination to participate in the program, the admission requirements of the Bachelor of Tourism Management are being revised to require only a letter of intent instead of a current resume and two letters of reference.

**09/82** The revision to the Bachelor of Tourism Management admission requirements be recommended for approval to the Senate.

Jackie updated the Committee regarding the curriculum software that is currently being implemented to allow for online program and course approvals.

The issue of course numbering was raised in regard to corresponding with the level of the course. There was discussion on the need to develop guidelines on course level and numbering. A committee was set up to review this issue. Members of this committee are:

Also, Jackie discussed the issue of bringing in an approval deadline for implementation of programs and changes to programs in order to allow sufficient time to have the programs in the calendar thus allowing students to have advance knowledge of the program requirements. Generally, the Committee agreed that discussion on this issue should initially take place at SCC, with a recommendation then taken to Senate. Jackie Snodgrass will work with the Registrar to bring forward a proposal for the November SCC meeting.
