COURSE FORMAT

1.5 hours of class time, 3 hours lab time, plus an additional 1.5 hours delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION

An introduction to web technologies and client-side web-application development, for students with prior coding experience. Students learn to apply a suite of fundamental technologies and techniques to build user interfaces and small web applications for the browser. Students develop a core understanding of how the Internet and World Wide Web work; how to design and develop HTML web pages styled with CSS; how to incorporate multimedia in their designs; how to add interactive functionality with JavaScript; and how to store application state in a server-side DB and/or in browser storage. Each student designs and builds a complete stand-alone project, published on the WWW.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Describe the client-server architecture of the WWW and how data is exchanged via HTTP;
- Develop the markup to create structured multimedia web documents using HTML;
- Explain the relation between elements of an HTML document and the browser DOM;
- Apply CSS styles using selectors to improve the web document's visual appeal and convey information about its structure;
- Design intuitive, easy-to-use user-interfaces for small web applications;
- Write event-driven programs that interact with the DOM to create dynamic user experiences;
- Load and present data from an HTTP API; Store application state data to an HTTP API;
- Identify core security and performance issues in web applications.

Students who complete this Numeracy course will be able to do the following:

- Apply both analytical and numerical skills to solve problems;
- Summarize and analyze data in quantitative forms;
- Interpret and draw conclusions from an analysis of quantitative data;
- Represent quantitative information in a variety of forms (e.g. symbolically, visually, numerically, and verbally);
- Incorporate quantitative evidence in support of an argument.

Students who complete this Science and Technology course will be able to do the following:

- Apply numerical and computational strategies to solve problems;
- Evaluate scientific information (e.g., distinguish primary and secondary sources, assess credibility and validity of information);
- Demonstrate how a problem, concept, or process can be modelled numerically, graphically, or algorithmically;
- Explain how scientific inquiry is based on investigation of evidence and evolves based on new findings;
- Participate in scientific inquiry and communicate the elements of the process, including making careful and systematic observations, developing and testing a hypothesis, analyzing evidence, and interpreting results.

Incomplete Grades

Grades of Incomplete "I" are assigned only in exceptional circumstances when a student requests extra time to complete their coursework. Such agreements are made only at the request of the student, who is responsible to determine from the instructor the outstanding requirements of the course.

Late Assignments

The due dates for all course activities are posted on eLearn. If you anticipate being late with a submission, please consult with your instructor beforehand.

Assignments will be penalized 10% if delivered within 24 hours after the deadline and then a further 20% for each succeeding day until solutions are available.

Missed Exams/Quizzes/Labs/etc.

Normally, a score of zero will be given for a missed exam, test, quiz, lab, etc. In some exceptional situations, the student will be permitted to write a make-up test, defer the lab to a later date or to replace the score by other marks.

The situations in which a score of zero may be avoided are those for which the student meets all of the following conditions:

1. Circumstances clearly beyond the control of the student caused the exam, test, quiz, lab, etc. to be missed. Such circumstances include serious illness or injury, or death of close family member. They do not include forgetting about the test, lack of preparation for the test, work-related or social obligations.
2. The student has notified the instructor (or the School of STEM office staff, if the instructor is not available) about the missed exam, test, quiz, lab, etc. Such notification must occur in advance, if possible, or at the latest, on the day of the exam, test, quiz, lab, etc.
3. Proof of the circumstances is provided.
4. The student has been fully participating in the course up until the circumstances that prevented the writing of the exam, test, quiz, lab, etc. Fully participating means attending almost all of the classes and turning in almost all assignments in the course.

The options offered to the student who meets the four conditions are decided by the instructor.

They will not necessarily meet the convenience of the student.

Accommodations can be made to honour community needs and traditional practices.

Attendance

Students are expected to attend and fully participate in all classes, labs and associated activities. Students should expect to log in to eLearn 3-4 times per week and to spend 8-10 hours per week on course readings, practice tests, weekly learning activities, teamwork and assignments. Students are responsible for all information given during lectures, labs and tutorials, including exam dates and assignment deadlines, even if they were unable to attend for any reason.

Students are expected to proofread all written work for any grammatical, spelling and stylistic errors. Instructors may deduct marks for incorrect grammar and spelling in written assignments.

original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.
