COURSE FORMAT

Three hours of class time, plus an additional hour delivered through on-line or other activities for a 15-week semester, which includes two weeks for final exams.

CALENDAR DESCRIPTION

This course examines the impact of contemporary crime prevention, surveillance and security practices. Students will learn how social control is achieved through a widening network of public and private agencies, including social services, law enforcement and urban planners, who regulate and 'police' our everyday interactions at the local, national and global levels. The second part of the course will focus on the targeting of minority and protest groups who are constructed as 'risks' to society, and impacts on Indigenous sovereignty.

COURSE NOTE

CRIM 202 is an approved Self and Society course for Cap Core requirements.

COURSE STUDENT LEARNING OUTCOMES

On successful completion of this course, students will be able to do the following:

- Understand the role of digital media in shaping new practices around surveillance and privacy.
- Explain how minority groups (including ethnicity, race, religion, ability, age, and class) are constructed, targeted, and controlled through surveillance.
- Analyze how the performance of identity is shaped through practices of surveillance.
- Assess different ethical issues raised in the collection and use of personal data both within Canada and internationally.

CRIM 202 Outline

- Distinguish different policies and regulatory schemes instituted around the world in regards to practices of surveillance and social control.

Students who complete this Self and Society course will be able to do the following:

- Identify potential root causes of local/global problems and how they affect local/global cultures, economies, politics, and policies.
- Assess and evaluate individual and collective responsibilities within a diverse and interconnected global society.
- Synthesize a range of differing community perspectives on ethics and justice and explain how these perspectives can inform structural change.
- Explain how contexts (e.g. cultural, historical, colonial, economic, technological) shape identity formation and social structures.

Fraud: Creation or use of falsified documents.

Misuse or misrepresentation of sources: Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

Plagiarism: Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

Self-Plagiarism: Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

Prohibited Conduct: The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
- Falsifying one's own and/or other students' attendance in a course;
