### **CALENDAR DESCRIPTION**

This course will explore the acute and chronic effects of exercise on body systems; specifically, cardiovascular, respiratory and muscular responses to physical activity will be examined.

## **COURSE STUDENT LEARNING OUTCOMES**

- 1. **Describe** the acute and chronic adaptations to exercise that occur in the cardiovascular, respiratory, neuromuscular, metabolic and endocrine systems.

- 3. **Categorize** exercise training protocols to enhance athletic performance and general health and wellness.

- 4. **Conduct** and **present** APA formatted lab reports.
- 5. **Perform** laboratory procedures that are common in exercise physiology such as submaximal exercise testing, lactate testing, etc.

- 2. Evaluate scientific information (e.g., distinguish primary and secondary sources, assess credibility and validity of information).
- 3. Demonstrate how a problem, concept, or process can be modelled numerically, graphically, or algorithmically.
- 4. Participate in scientific inquiry and communicate the elements of the process, including making careful and systematic observations, developing and testing a hypothesis, analyzing evidence, and interpreting results.

The assignment structure for this course is determined by the instructor in accordance with the learning outcomes outlined above. Please refer to the course syllabus and eLearn site for a detailed breakdown.

**Lecture Quizzes:** This course will include a number of multiple-choice quizzes covering selected course material. Quizzes will be issued online and will have a time limit for completion.

**Lab Research Project:** This course will include a group research project where group members will perform a literature review on a self-selected topic. A hypothesis will guide your review of the current research available on your topic with findings presented in APA formatted paper.

**Lab Reports:** Lab assignments will be assigned to interpret common laboratory procedures in exercise physiology and how they relate to lecture content. Lab assignments will be due one-week after the completion of the lab class.

**Midterm Exam:** There will be a midterm exam covering all material up to and including the week before the midterm. The format of the exam will be determined by the instructor and may include a combination of true/false, multiple choice, fill in the blanks, short answer and long answer questions.

**Final Lab Exam:** The final lab exam will assess your ability to conduct assessments performed during class time. This exam will include practical application and calculations of physiological variables.

**Final Written Exam:** The final exam will be drawn from all lecture material and will be structured similarly to the midterm exam. The final exam may be cumulative (please consult your instructor).
