## COURSE FORMAT

2 instructional hours per week for 15 weeks, including two weeks for final exams.

## CALENDAR DESCRIPTION

This course is an introduction to improvisation from a music therapy context. Students will explore their relationship to music, themselves, and others using improvisation. This course offers students an experiential journey through sound-making, organized and free flow improvisation, and the application of improvisation styles and techniques with a variety of populations.

## COURSE STUDENT LEARNING OUTCOMES

**On successful completion of this course, students will be able to do the following:**

- a) form relationships based on music improvisation;
- b) demonstrate a variety of improvisation styles, including for youth and children;
- c) express themselves using a variety of instruments including their major instrument;
- d) analyze improvisation in basic ways; and
- e) lead simple group and individual improvisations.

## COURSE CONTENT:

Classes combine a variety of musical experiences, lecture and analysis.

1. Introduction to improvisation.

2. Basic music therapy improvisation and the elements of music: rhythm, melody, harmony, timbre, chords and chord progressions.
3. Introduction to equipment.
4. Techniques for 1-1 and group work.
5. Rhythm Band.

### Weekly Improvisation Assignment

Both small group and individual 30-minute improvisations will be played outside of class to develop the skill of clinical improvisation. As clinical improvisation, the purpose is to use music to reach a non-musical goal. Mention your improvisation in your diary. Marks are for completion of the amount of time spent, up to 30 minutes a week and not the quality of the improvisation.

### Diary

Hand in each week a one-page reflection on the previous class and homework improvisation. Focus on the feelings, thoughts and sensations felt during these periods. There is not a correct answer and marks are awarded on the basis of length of submission (up to one page) and timely submission of assignments.

### Professionalism

Marks are awarded to students actively participating in musical creation, role-playing and class discussion, and for demonstrating professionalism in a career training program (including but not limited to punctuality, attendance, communication, and teamwork).

### ASSIGNMENTS:

- 1) A diary of reactions to each class and improvisation homework sessions.
- 2) Improvisations will be assigned each week for homework.
- 3) Class participation is an integral component of this course.

### GRADING PROFILE

**Incomplete Grades**

Grades of Incomplete "I" are assigned only in exceptional circumstances when a student requests extra time to complete their coursework. Such agreements are made only at the request of the student, who is responsible to determine from the instructor the outstanding requirements of the course.

**Late Assignments**

Marks will be deducted for the late submission of assignments. The penalty for the late submission of an assignment is .5 of a mark per day. After one week, late assignments will not be accepted.

**Academic dishonesty** is any act that breaches one or more of the principles of academic integrity. Acts of academic dishonesty may include but are not limited to the following types:

**Cheating:** Using or providing unauthorized aids, assistance or materials while preparing or completing assessments, or when completing practical work (in clinical, practicum, or lab settings), including but not limited to the following:

- Copying or attempting to copy the work of another during an assessment;
- Communicating work to another student during an examination;
- Using unauthorized aids, notes, or electronic devices or means during an examination;
- Unauthorized possession of an assessment or answer key; and/or,
- Submitting of a substantially similar assessment by two or more students, except in the case where such submission is specifically authorized by the instructor.

**Fraud:** Creation or use of falsified documents.

**Misuse or misrepresentation of sources:** Presenting source material in such a way as to distort its original purpose or implication(s); misattributing words, ideas, etc. to someone other than the original source; misrepresenting or manipulating research findings or data; and/or suppressing aspects of findings or data in order to present conclusions in a light other than the research, taken as a whole, would support.

**Plagiarism:** Presenting or submitting, as one's own work, the research, words, ideas, artistic imagery, arguments, calculations, illustrations, or diagrams of another person or persons without explicit or accurate citation or credit.

**Self-Plagiarism:** Submitting one's own work for credit in more than one course without the permission of the instructors, or re-submitting work, in whole or in part, for which credit has already been granted without permission of the instructors.

**Prohibited Conduct:** The following are examples of other conduct specifically prohibited:

- Taking unauthorized possession of the work of another student (for example, intercepting and removing such work from a photocopier or printer, or collecting the graded work of another student from a stack of papers);
