CALENDAR DESCRIPTION

This course develops sight-reading skills and aural perception of tonality, with specific reference to seventeenth and eighteenth-century repertoire, in support of MUS 100 and 120.

- Transcribe melodies, harmonies, and rhythms as a means of reflecting their comprehension of tonality, after aural and vocal drill, solfege, and dictation practise;
- Demonstrate a variety of learning processes using class, internet, and other resources, in individual and ensemble work'
- Employ various ear and sight methodologies (Kodaly/Orff, Curwen hand signs, conducting patterns) necessary to working musicians and music educators;

• Display leadership and oral communication abilities by working collaboratively.
